They were reportedly caught on July 22, 1963, trying to slip into Cuba with arms, material for secret writing, and "instructions from CIA to organize spy nets and sabotage against the national economy." On August 19, 1963, Mr. Richard Tansey, CIA, advised the Liaison Agent that the above three individuals were under the control and in the employ of CIA at the time of their arrest by Cuban security forces.
