From personal knowledge of ALEX RORKE, JR., the NYO is convinced that if RORKE were alive he would somehow manage to contact his wife or friends. Although RORKE in the past has been accused of doing many reckless and unthinking things, nevertheless, he was a devoted husband and father and always was in contact with his family whenever traveling.
