SUBJECT: Joaquin PALACIO, Suspected Cuban Intelligence Service Agent

1. During the week of 17 March 1963 an untested source in Santo Domingo was told by an administrative employee in [redacted]

[redacted] that Joaquin PALACIO, a Cuban national, is suspected of being a Cuban Intelligence Service agent in the United States. The administrative employee added that PALACIO is the brother of Mrs. Angel MIOLAN, the wife of Angel MIOLAN, president of the Partido Revolucionario Dominicano (PRD - Dominican Revolutionary Party); also that PALACIO is married to Quisqueya DIAZ de PALACIO, a Dominican national, who is an employee of the United Nations in New York City and that he and his wife live in New York City in the vicinity of 600 Broadway.

2. This office has no additional information on PALACIO.
