By airmail, we are sending you information regarding manifestations of the sorrow of the Government of [ ] because of the assassination of President KENNEDY, consisting of messages to President LYNDON B. JOHNSON, Secretary RUSK and Mrs. KENNEDY, as well as a decree declaring a three-day period of official mourning.

The Foreign Minister will attend, as the personal representative of our Chief Executive, the funeral ceremonies which will be held this coming Monday in Washington.
