The Chairman. The hearing will please come to order.

Mr. Bundy, would you please stand and take the oath.

Do you swear that the testimony you will give in this hearing will be the truth, the whole truth and nothing but the truth, so help you God?

Mr. Bundy. I do.

The Chairman. Mr. Schwarz.

TESTIMONY OF McGEORGE BUNDY

Mr. Schwarz. Would you state your full name and address for the record, please?

Mr. Bundy. My name is McGeorge Bundy. I live in New York. My home address is 1040 Fifth Avenue.

Mr. Schwarz. And you are currently the Chairman or the President of the Ford Foundation?

Mr. Bundy. The President of the Ford Foundation.

Mr. Schwarz. In the Kennedy Administration what position did you hold?

Mr. Bundy. I was Special Assistant for National Security Affairs.

Mr. Schwarz. And you held that all the way through the Kennedy Administration and for how many years in the Johnson Administration?

Mr. Bundy. I held that office from the beginning of the Kennedy Administration to the end of February 1966.

Mr. Schwarz. Prior to commencing work with the Kennedy

1 Administration, had you had anything to do with the Central
2 Intelligence Agency?

3 Mr. Bundy. I had a brother who worked for many years in
4 the Central Intelligence Agency. I occasionally talked with
5 members of the Agency during the forties and the fifties, both
6 about substantive questions of what one thought about the
7 conditions in the Soviet Union, and occasionally also about
8 efforts that they were then making to recruit talented
9 graduates of colleges.

10 Mr. Schwarz. You mentioned your brother. To put some-
11 thing of a different kind in the record than we have gotten
12 recently, would you recount the position taken by Allan Dulles
13 in connection with the problem that your brother had in the
14 1950's.

15 Mr. Bundy. Well, my brother came under attack from
16 Senator Joseph McCarthy. And the ground was, as I recall
17 it, in general that he had been a friend and supporter of
18 Alger Hiss and was therefore not to be trusted in a place
19 as sensitive as the Central Intelligence Agency.

20 Allan Dulles -- and my impression is that this was
21 quite characteristic of him -- took an extremely firm stand
22 on this matter, and stood by his estimate that my brother was
23 in fact in no sense a security risk, rather, to the con-
24 trary. And the defense was successful, and my brother
25 continued in the Central Intelligence Agency until the Kennedy

1 Administration came in, at which time he moved over to the
2 Defense Department.

3 Mr. Schwarz. We have indicated to you that we are going
4 to discuss the countries of Cuba, the Dominican Republic and
5 Vietnam, although not much on Vietnam. And the majority and
6 minority staff have shown you some documents of that period,
7 some 15 years ago. Before I get to those three countries,
8 I would like to ask you some questions about a subject
9 called Executive Action. Have you ever heard of the subject
10 called Executive Action?

11 Mr. Bundy. Yes, I have.

12 Mr. Schwarz. When did you first hear of it?

13 Mr. Bundy. Well, as I have told your staff, that is a real
14 difficulty for me, because I cannot pinpoint the time at
15 which I heard of it. My impression was that it was some time
16 in the early months of 1961.

17 Mr. Schwarz. And do you have a recollection as to the
18 context in which you heard about it, the person from whom you
19 heard about it, and will you provide to the Committee your
20 full recollection of the subject of Executive Action in the
21 early 1961?

22 Mr. Bundy. Would it help if I try to describe in a
23 general way what I now understand of this matter, the
24 part which is recollection and the part which is clarified
25 by discussions with the staff and what I now think about it?

1 Mr. Schwarz. Would you distinguish, though, the part
2 that is recollection and the part that is based upon other
3 matters?

4 Mr. Bundy. That is exactly what I would like to do.

5 The part that is recollection is very vague. And I
6 would say that I have no recollection of more than one conver-
7 sation on this subject. And the impression that sticks in
8 my mind is that I was told about it in a general way. And
9 it was described to me as an effort to study through the
10 possibilities by which one might act against an individual
11 in a context other than that of espionage and counter-espionage,
12 a context more political.

13 Mr. Schwarz. When you say "act against an individual",
14 act in what fashion?

15 Mr. Bundy. Act in a variety of fashions, as I recollect
16 it, but up to and including killing the individual.

17 The two things that I think are clear in my recollection
18 about that -- three -- one, that it was a concept presented
19 or described to me -- I was in effect being briefed on it.

20 Two, that it was entirely an untargetted -- that it
21 was in no sense a plan to do anything to anyone.

22 And third, and I think quite important, that it was
23 not an operation which had any specific target.

24 Mr. Schwarz. You said you were in effect briefed on it.
25 By whom?

1 Mr. Bundy. That is what I don't know. I cannot
2 recollect who it was. And I think it inappropriate to guess
3 when I have no recollection.

4 Mr. Schwarz. What time? I don't mean what time of day,
5 but what time?

6 Mr. Bundy. As I say, sometime I think in the early
7 months of 1961. And searching memory is an uncertain busi-
8 ness, but it sticks in my mind that I heard about it in the
9 rooms of the Executive Office Building. And that
10 would place it in time, because I moved from the Executive
11 Office Building to the West Basement of the White House sometime
12 after the Bay of Pigs, perhaps in May.

13 Mr. Schwarz. So based on that fact you place it in
14 time sometime prior to the Bay of Pigs and sometime after--

15 Mr. Bundy. After my arrival in Washington.

16 Mr. Schwarz. And when did you arrive in Washington?

17 Mr. Bundy. About the 10th of January. I would place
18 it more closely, because I think it was after I was in the
19 Office of the Special Assistant, which, of course, was occupied
20 until the 20th of January by others.

21 Mr. Schwarz. So you place it after the 20th of January,
22 but before the Bay of Pigs, which was April 14 or 17?

23 Mr. Bundy. That is right.

24 Mr. Schwarz. Did it come up in a context where you
25 urged that such a capacity be created?

3 Mr. Bundy. It came up in a context in which it was being
4 described to me by someone else. And that is really about
5 as far as I can take it with precision.

6 Mr. Schwarz. Was it described to you by someone else
7 as a capacity in being?

8 Mr. Bundy. As a capacity -- and this is not something
9 I want to be too certain about, Mr. Schwarz, but my recollec-
10 tion would be that it was a capacity coming into being.

11 Mr. Schwarz. Now, receiving that information, did you
12 take any steps to discourage or dissuade the person, whoever
13 it was, who was describing to you the capacity coming
14 into being?

15 Mr. Bundy. What I recollect is that I was satisfied with
16 the description I received on two points.

17 First, that this was not an operational activity, and
18 would not become such without two conditions: first, that
19 there be a desire or a request or a guidance that there
20 should be planning against some specific individual; and
21 second, that there should be a decision to move against an
22 individual.

23 Being satisfied that these two things were not happen-
24 ing -- and I am now giving you a reconstruction rather than
25 a precise recollection -- I am confident that what I did was

1 to place this notion in the category of hypotheticals, of
2 things with no current urgency to them, and in that sense
3 not a question that cried for attention in the sense that
4 so many others did. If I may make a straightforward compari-
5 son, we were, I think, even before the inauguration, but
6 certainly very quickly thereafter, very heavily engaged in
7 a real question of choice, which was the question of choices
8 around what would you do with the Cuban brigade which led
9 eventually to the Bay of Pigs. And that occupied a very
10 large amount of time and attention, as did the crisis in Berlin
11 and the crisis in Laos.

12 In the same period there were briefings on contingency
13 plans for the uses of nuclear weapons, other weapons, and a
14 whole swarm of, sort of, and here were reports that came
15 naturally to the Special Assistant's office, which was also
16 being reorganized.

17 So, I think that what I did was simply to put this one
18 aside. I cannot claim to have thought about it seriously,
19 because it was in the flow of business that would come to the
20 Special Assistant's office.

21 Mr. Schwarz. I want to see if we can be more precise
22 on dates to check on what other evidence we have. We have
23 other evidence that discussions of this matter were going
24 on in the Central Intelligence Agency on the 25th and 26th
25 of January 1961.

1 Now, are you able to testify with respect to the likeli-
2 hood of the conversation you have recounted taking place
3 prior to the 25th or the 26th of January 1961.

4 Mr. Bundy. I would rate it very, very unlikely.
5 This is a matter I have thought about since you did mention
6 those dates to me. And I would say that the chance that
7 within the first four days after being sworn in I would have
8 been drawn to consider this question is, from my side, as
9 near zero as I can put it. I had been teaching international
10 relations over a period of ten years. I was deeply interested
11 in many of the immediate problems, most notably the problem of
12 the crisis in Berlin and the concomitant question of relations
13 with the Soviet Union. And I was preoccupied with all of
14 the things that happened when you moved to Washington from
15 helping the Secretary to buy a house, and working out a
16 staff, and I was under instruction from the President to
17 reorganize the White House National Security staff. This
18 subject was far out of my mind, and I would not have brought
19 it up. I doubt that anyone would have brought it to
20 me in those early days.

21 The Chairman. May I interrupt for a moment.

22 As I understand your testimony, Mr. Bundy, you were
23 briefed on the concept of Executive capability sometime early
24 in 1961, and you can't remember now who it was who briefed you.

25 Do you recall whether or not you instructed anyone at

1 the CIA to develop such a capability?

2 Mr. Bundy. I am sure I gave no instruction. But it is
3 only fair to add that I do not recall that I offered any
4 impediment after I was briefed.

5 The Chairman. But your best recollection is that some-
6 body told you that such a capability was being developed?

7 Mr. Bundy. I don't want to be too firm on that, but that
8 would be my best recollection.

9 The Chairman. We received testimony from Mr. Bissell.
10 Are you acquainted with Mr. Bissell?

11 Mr. Bundy. Yes, sir. I have known him a long time, and
12 he has been a great friend of mine.

13 The Chairman. Mr. Schwarz, - since you are very familiar
14 with the record, are you going to take Mr. Bundy through the
15 record of Mr. Bissell's testimony?

16 Mr. Schwarz. Mr. Bissell testified --

17 The Chairman. And we have the transcript. If it would
18 be helpful for Mr. Bundy to look directly at the transcript.
19 I think he should have it.

20 Mr. Schwarz. Mr. Bissell's testimony was, first, that
21 in the first instance he said he did not recall any specific
22 conversation. Then, however, he said, after having reviewed
23 certain notes by Mr. Harvey, he concluded that if Mr. Harvey's
24 note indicated, as they did, that he, Bissell, told Harvey
25 in 1961 that he had been twice urged by the White House to set

1 up an Executive Action capability, then he had no reason to
2 doubt that testimony. And then he went on through a series
3 of comments to end up saying that he would have been given
4 that urging by either Rostow or Bundy, more likely Rostow.

5 First, let's focus on Rostow. Was Rostow involved in
6 the briefing?

7 Mr. Bundy. No -- now, that I can't tell you out of my
8 recollection, but only out of my knowledge of the way the
9 office was organized. The first things we did, Walt Rostow
10 and I, was to work out an informal but nevertheless reasonably
11 clear-cut division of labor. And the whole business of
12 what I thought of as special group business, namely, matters
13 that related to covert action, and would, if they came for
14 division, come through the special group, fell on my side
15 of that division. I don't recall that Mr. Rostow was ever
16 involved in any matter of this sort.

17 The Chairman. It is fair to say that this was Mr. Rostow's
18 testimony.

19 Mr. Schwarz. Mr. Bissel is, as you say, a friend of
20 yours of long standing, and still is a friend of yours?

21 Mr. Bundy. Yes, he is.

22 Mr. Schwarz. We have his testimony which, while it did
23 have gradations within it, ended up saying that
24 he believed either you or Mr. Rostow urged him to set up the
25 Executive Action capability. And you have testified that the

1 fact is that you were given a briefing, and you didn't urge it,
2 but on the other hand you didn't say it should stop.

3 How can you explain, if you can, the testimony of your
4 friend Mr. Bissell, and the contrast between that and
5 your testimony?

6 Mr. Bundy. Well, as I understand Mr. Bissell's testi-
7 mony -- and I should add, so that there will be no misunder-
8 standing, that I have not only the advantage of discussions with
9 you, but I have talked with him about it -- as I understand
10 that testimony from that conversation, he was trying to ex-
11 plain a situation in which he had no reason to question an Agency
12 history to the effect that he first gave instructions on this
13 matter in February 1961. And in that context -- and he had
14 no reason to question the report that he had received
15 White House encouragement -- it is in that context that his
16 speculations about Mr. Rostow and about me seem to fall.

17 I would be surprised, if his memory were refreshed
18 with respect to the dates of January which you have des-
19 cribed to me, if he were to believe that any initiative in
20 this enterprise would come in the first instance from the
21 Kennedy Administration.

22 The Chairman. Mr. Bundy, our transcript of the
23 Bissell testimony makes it clear that Mr. Bissell himself
24 does not dispute the documented record. He said in effect,
25 if Harvey says that I told him that I had been twice instructed

1 by the White House to develop an Executive capability, I
2 have no basis on which to dispute that record.

3 Then when we asked him, very well, who in the White
4 House told you, and when were you told, he replied, it
5 must have been early in 1960, and I don't recall who told me,
6 but it must have been either Rostow or Bundy.

7 He then recounts that he had numerous conversations
8 with both of you during the period, and concludes that the
9 instruction must have come either from you or from Mr. Rostow.

10 Now, Mr. Rostow tells us he never gave such an instruc-
11 tion, and in fact has no memory of every having discussed
12 such an instruction.

13 Mr. Bundy. He would have in fact have had no authority
14 to give such an instruction.

15 The Chairman. That is right.

16 And he pointed that out.

17 Mr. Bundy. And in fact I wouldn't have the authority
18 to give any such instruction, and I would have been only
19 the channel to give such instruction.

20 Senator Baker. Who would have had the authority?

21 Mr. Bundy. If the authority were required outside the
22 Agency it would have to have been the President himself.

23 The Chairman. What I would like to ask you --

24 Mr. Bundy. Could I continue with Senator Baker's
25 question for one second.

1 My own impression as to this matter -- and I have already
2 testified to the fact that I am relying on a recollection of
3 a meeting of which there is no record -- is that had I been
4 briefed on this essentially hypothetical internal, undirected
5 character, it did not appear to me to be a matter that required
6 further authority outside the CIA. That may or may not have
7 been right, but that is the quick judgment I appear to have
8 reached. Because I certainly did not raise the question with
9 others.

10 Senator Baker. Do you recall that, Mr. Bundy, or is that
11 your surmise?

12 Mr. Bundy. That is my reconstruction more than my --
13 I know I did not raise it, I did not press the question, and
14 I did not feel, therefore, that it was a question that needed
15 further analysis, and it did not, so far as I know, get
16 further consideration in the White House. My own recollection
17 is that I didn't hear the words again in any serious con-
18 text that I can recall until this year.

19 The Chairman. And you cannot recall who it was who
20 briefed you?

21 Mr. Bundy. I really cannot.

22 Mr. Schwarz. Can you narrow the field?

23 Mr. Bundy. I can narrow the field. It would have to have
24 been a senior officer at the Agency, or someone with previous
25 understanding in the White House. I have no reason to suppose

1 that it was the latter, but I cannot exclude that.

2 The Chairman. Might it have been Bissell himself?

3 Mr. Bundy. It surely might have been.

4 The Chairman. Based upon your best recollection of that

5 briefing, you have already testified that you interpose no

6 objection?

7 Mr. Bundy. I am pretty sure I satisfied myself as to

8 the character of the enterprise. But I did not interpose an

9 objection.

10 The Chairman. Do you recall, then, having reported the

11 briefing to the President?

12 Mr. Bundy. No, I don't.

13 The Chairman. Did it strike you -- before I ask that

14 question, based upon your best recollection of the briefing,

15 were you told that this was a new capability that was being

16 developed, or were you told simply that the Agency possessed

19 such a capability, but without any great sense of precision.

1 House authority, I know from the context -- my own concept
2 of my job what I would have done.

3 The Chairman. What would you have done?

4 Mr. Bundy. I would have had to take the matter to the
5 President, because I had no independent authority.

6 The Chairman. And you have testified that you did not
7 take the matter to the President?

8 Mr. Bundy. As far as I can recall, Mr. Chairman.

9 The Chairman. Well, this is a subject dealing, as it
10 does, with the development of a capability to kill that would
11 have been of the character that if you had been asked for
12 authority you would have discussed with the President?

13 Mr. Bundy. That is right.

14 The Chairman. And furthermore, is it not a subject of
15 a character that you would be very likely to recall?

16 Mr. Bundy. If I had been asked for authority I would
17 recall it. If I were the initiating or deciding agent, I
18 would recall that I had had that role.

19 You speak of the seriousness of it. It deals with a
20 capability to kill. One of the sobering facts about coming
21 into the government from outside into a sensitive position
22 like that one is the number of things on which you are briefed
23 which deal with the capability to kill. Contingency plans
24 for protecting West Berlin, contingency plans for the use of
25 nuclear weapons -- shelf plans, a shade more remote, perhaps,

1 for the use of different kinds of gases -- an operational plan
2 for the invasion of Cuba -- these were uncertainties as to
3 whether there would have to be military landings in Laos. In
4 the context of 1961 -- and I am not in any sense trying to un-
5 derstate the seriousness of the context of 1975-- this was a
6 hypothetical kind of a thing with two strong locks between
7 it and any decision. And I simply didn't pay it the attention
8 then that we are paying to it now. We are right to pay
9 that attention now.

10 The Chairman. I understand that very well. And this
11 Committee is endeavoring in every way it can to place this
12 whole issue within the context of the time. Nevertheless, we
13 are faced with a very real dilemma. We know that at the very
14 time you were being briefed the Agency was not only interested
15 in developing a capability, but was in fact engaged in a
16 series of attempts to assassinate Castro, and had been in-
17 volved in other murder plots and murder attempts against the
18 leaders of certain foreign governments.

19 The question we are endeavoring to answer is whether
20 the Agency had been authorized by the policy makers of the
21 government to engage in this activity, or whether it was
22 operating fast and loose on a wild gambit of its own in an
23 area of extreme sensitivity that could have the most serious
24 repercussions upon the government of the U.S. and its
25 reputation in the world.

1 We are told by Mr. Bissell, who apparently was not only
2 a very good friend of yours, but also a very good friend of Mr.
3 Rostow's --

4 Mr. Bundy. That is right.

5 The Chairman. -- a man whose credibility as a witness
6 would seem to have to be respected -- that he was at least
7 engaged in developing such a capability on direct instructions
8 from the White House.

9 But when we pressed him for specifics, his testimony
10 becomes very vague. He can't remember just who it was who
11 told him, he can't dispute the record, which says that in effect,
12 he so advised Mr. Harvey when he engaged Mr. Harvey to develop
13 the capability. And everyone else of high authority in
14 the Administration that we have questioned so far testifies
15 that it was not the policy of the Administration to engage in
16 assassination, and no such attempts were ever authorized,
17 and indeed, with the exception of one occasion in the Special
18 Group, the subject never even surfaced for discussion.

19 And when it did, if it did, it was quickly shot down.

20 Nevertheless, the CIA was in fact embarked upon such
21 attempts during the period under review.

22 Now, we are led to conclude either that we are not
23 being told the truth concerning the policy of the Administration,
24 which is very hard for me to accept, given the reputation of
25 the witnesses that have come before us, for integrity and

1 truthfulness, or that the CIA was running wild, and acting on
 2 its own initiative, engaging in murder plots, murder attempts,
 3 and not informing, let alone securing the authority from,
 4 those in government who held the responsibility, which in a way
 5 is even more frightening.

6 Now, you tell us that you remember being briefed. You
 7 don't remember advising the President. It didn't seem too
 8 important at the time. Did you ever follow up on whether such
 9 a capability had in fact been perfected by the agency?

10 Mr. Bundy. I don't recall pursuing the matter at all,
 11 Mr. Chairman, any more than I would have pursued any other
 12 shelf capability on which no question was being pushed to me,
 13 either from below or above.

14 If I may go back and comment on one aspect of your,
 15 I think, important and impressive description of
 16 the difficulty the Committee faces, I am sure that if in the
 17 early months of 1961 I had known what I now know, in part from
 18 the newspapers and in part from discussions with your staff,
 19 about what was really in train, I would have had a very
 20 different approach.

21 Senator Mondale. Mr. Chairman.

22 The Chairman. Senator Mondale.

23 Senator Mondale. Yesterday Secretary Rusk testified be-
 24 fore us. And some of the minutes or notes made following one
 25 of the meetings of the Special Group Augmented at least suggest

7 at which such matters would be discussed.

8 Would you comment on that?

9 Mr. Bundy. Yes. My impression would be that the
10 Secretary was probably referring to the much discussed meeting
11 of August 10, 1962.

12 Senator Mondale. Right.

13 Mr. Bundy. That was a large meeting, 16 or 18 people.
14 And the comment seems to be pertinent to that meeting. The
15 Special Group as such, the one which I would have had in
16 mind, for example, in early 1961, was set up under a national
17 security regulation of some sort whose number was 54/12.

18 Senator Mondale. That was the Special Group.

19 Mr. Bundy. That was the Special Group. And the Special
20 Group in and of itself was quite a small group.

21 Senator Mondale. But people would volunteer to attend --

22 Mr. Bundy. No.

23 Senator Mondale. They would not?

24 Mr. Bundy. No. The meeting of August 10 is a very
25 special meeting in a variety of respects. That included --

1 The Chairman. You were present at that meeting?
 2 Mr. Bundy. I was present. My memory is entirely
 3 a refreshed memory on this, I had no recollection of the
 4 meeting until recent months. But I have found a scratch
 5 pad that I apparently doodled on on that date, and it
 6 shows who was there, and not much else.

7 Mr. Schwarz. There were some beautiful drawings.

8 Mr. Bundy. There were.

9 They were not very beautiful drawings.

10 The Special Group Augmented met in August -- and this
 11 does coincide with my general recollection of the matter --
 12 in response to concerns which were first, I think, and most
 13 energetically pressed by Mr. McCone with respect to, what the
 14 hell are the Russians doing in Cuba. And that was the center
 15 of that meeting, and the center of later meetings, and the cen-
 16 ter of a national security action memorandum of considerable
 17 complexity which was put out toward the end of August, most
 18 of which dealt with this question, how do we know what they
 19 are going to do, what do we do if they do it, and so forth,
 20 with respect to missiles in Cuba.

21 It was therefore in a sense much more than an ordinary
 22 MONGOOSE meeting, let alone a Special Group meeting. And
 23 while I quite agree with the Secretary that that meeting as
 24 a planning session for anything as horrendous as assassina-
 25 tion is implausible in the extreme. Quite serious covert

1 actions were discussed in the Special Group. And as your
2 Committee pursues its studies of covert action it will find
3 that that group is the nodal point for policy decisions, good
4 or bad, well or badly handled. And that was quite a small
5 group.

6 Senator Mondale. The reason I ask that is that it seems
7 to me that the Chairman's question pursues the two alternatives,
8 either what we now know to have occurred was ordered at the
9 highest level, or at a very high level, such as the Special
10 Group Augmented, or they operated on their own, in which case
11 they were out of control and irresponsible, or there was some
12 extra communications system that went around the formal struc-
13 ture that we have been examining, and would account for the some-
14 of authority that these operators testified to when they
15 were with us.

16 Now, their testimony was not very specific. They said,
17 we thought we had authority, and we think we heard from
18 somebody, and so on.

19 What are the changes, based upon your experience, that
20 there was such extra official communications and order passing

21 Senator Baker. Before Mr. Bundy answers, I might say
22 to Senator Mondale that I am struck by the first paragraph
23 of the Inspector General's report, which we don't have here
24 now, I don't believe, but as I remember it, it says, it is
25 difficult to reconstruct history of assassination plots, because

1 of the high sensitivity of the subject matter, no written
2 records were kept, and it was not discussed at open meetings.
3 That is generally what was said. And it seems to me that is
4 implying, then, that as a matter of policy there was no
5 formalization of this sort of communication.

6 I am sorry to interrupt.

7 Senator Mondale. Yes.

8 And in that August 10 meeting two or three principals
9 testified that it did come up. And in fact it is not reflected
10 in the notes.

11 Mr. Bundy. Perhaps the best way for me to begin at least
12 with an answer to your question is to describe my
13 own sense -- my own understanding of the way in which covert
14 operations of all types were brought forward. And this was
15 perhaps the most important and the most constantly reiterated
16 fact of the process that I was exposed to when I began to
17 consider this whole range of subjects on coming to Washington.
18 And whether it was with Mr. Gordon Gray, my predecessor, or
19 with Allen Dulles, or with incoming and outgoing friends in
20 the Department of State, or with Mr. Bissell, or with anyone
21 else concerned with these matters, what I learned then and
22 what I applied throughout my time there to the best of my
23 ability was that all covert operations, whether intelligence
24 operations, clandestine political activity, and clandestine
25 propaganda activity, and clandestine subversion, or sabotage,

1 which did occur in the case of Cuba, all of them took their
2 authority from and came for their authority to the 54/12
3 group.

4 And when there was a question in such a meeting as to
5 whether the matter required further judgment, it was the
6 responsibility of the Chairman of that group to make sure that

8 The papers will usually say, higher authority, et cetera,
9 et cetera, and the President's name will often not appear --
10 any more than the precise character of the operation is likely
11 to appear in the minutes for the reasons that Senator Baker
12 has spoken of.

13 But I never knew of any operation of this kind of any
14 sort, with one exception, which is quite different, which did
15 not have that channel. The exception is the Bay of Pigs,
16 which was so big, so complicated, and overflowed in so many
17 directions, and in which the President himself was involved in
18 so many ways, as he fully recognized and explained at the time,
19 that it did not go through this Committee process, it went
20 through a quite Presidential process, and everybody involved
21 knew that.

22 But with that one exception, I would have told you up
23 until the beginning of this current public discussion, that
24 was the way it went, and that nothing went outside it, and
25 that the Agency and the Defense Intelligence Agencies, with

8 pardon for interrupting.

9 I am wrong in that things happened that didn't go through

16 own, and our attempts to find direct authority in these official
17 meetings led us nowhere.

18 And your testimony is that you find it very unlikely
19 that there was this covert way of communicating authority.

20 Mr. Bundy. My testimony was that I wouldn't
21 have believed it existed. I have to consider the same al-
22 ternative that the Chairman has so clearly pointed out. I
23 don't find it agreeable to conclude that the Agency was a
24 rogue elephant at a time when I strongly believe it was not.

25 Senator Mondale. We asked General Taylor that question,

1 and he said he found it incredible to believe that they
2 would have gone around the Special Group Augmented with such.

3 Mr. Bundy. General Taylor, of course -- and this is an
4 important point -- was appointed to this responsibility after
5 the Bay of Pigs, after a review of the failures that led to
6 the Bay of Pigs, and after a conclusion had been reached that
7 it would strengthen the White House to have a man with a parti-
8 cular responsibility for the oversight of intelligence opera-
9 tions. He was called military representative to the President,
10 but in the announcement of his appointment -- I happened to
11 look it up the other day -- President Kennedy made it clear that
12 he would be his representative for intelligence matters.
13 And he did in fact take over the chairmanship during the time
14 that he was military representative of all of the Special
15 Groups, 54/12, the Special Group Counterinsurgency, and the
16 Special Group Augmented, MONGOOSE. And when he said --
17 if he has testified that his expectation would have been
18 that nothing was going to go around him, he is saying exactly
19 what I thought through the same period.

20 Senator Baker. Mr. Chairman, in that respect --

21 The Chairman. Before I forget the question, let
22 me ask, since you were at the August 10 meeting, and since
23 we have received testimony buttressed by certain documentary
24 evidence that the subject of assassination of Castro did
25 come up at that meeting, do you have any recollection of

7 wouldn't want to testify that I never heard anyone say,
8 there is somebody thinking about this, because that would be
9 different from my vague recollection.

10 But I have no recollection of that meeting, and there-
11 fore none of any specific statement made by anyone in it.

12 The Chairman. Senator Baker?

13 Senator Baker. In that connection, before I go to the
14 question I had in mind, is it fair to say, Mr. Bundy, that
15 all, or virtually all, of your testimony this morning, about
16 MONGOOSE, about the August 10 meeting, and about the general
17 situation, is from reconstructed memory rather than first
18 impression memory?

19 Mr. Bundy. I didn't want to go that far, Senator Baker.
20 My knowledge, my sense of what 54/12 and Special Group
21 Augmented were, and where they stood in the line of authority,
22 is very clear, and is not reconstructed. I spent five
23 years -- except for the time when General Taylor was there,
24 I was the chairman of these things.

1 On the question of the Executive Action capability, I
2 believe referred to as the ZRRIFLE project --

3 Mr. Bundy. I must say that if I had known that was its
4 name I would have looked harder, Senator Baker.

6 to Executive Action Capability, or ZRRIFLE, do you have a
7 separate recollection?

8 Mr. Bundy. I have a recollection of what I think of
9 is one, I don't want to say there wasn't more, but of

11 it in some fashion at the time.

12 Senator Baker. Do you remember by whom?

1 Do you recall that there was not?

2 Mr. Bundy. I can only speak for myself here, and for

3 my colleague Rostow, and my knowledge of his assignments.

4 I recall that his assignments would have made it wildly out

5 of place, and totally out of character, for him to initiate a

6 matter of this kind. And I recall that I did not. And I

7 recall that quite independently of any reconstruction of

8 recent months.

9 Senator Baker. I would like to limit this, then,

10 just to your assignment.

11 Was it your general assignment to take care of so-

12 called covert operations?

13 Mr. Bundy. It was my assignment -- may I take a minute

14 on this?

15 Senator Baker. Yes, sir.

1 Mr. Bundy. I don't think the President ever acted Ian
2 Fleming.

3 Senator Baker. I think that is right. But I think it
4 is important for us, Mr. Bundy, to try to establish, as the
5 Chairman said, the range of available information or evi-
6 dence that sheds some light on the three alternative possi-
7 bilities, and the type of things that the President interested
8 himself in is terribly important in that respect.

9 I believe that you said you had no information or no
10 recollection of what particular situation, or what other
11 deals that were made he was interested in.

12 Mr. Bundy. I will put it more concretely than that.

13 The President said, can't we do something more about Cuba?
14 Why don't you get ahold of these people who are dealing with
15 this and see if they can't do better, and pass the word
16 that I am interested, that kind of thing.

18 spoke of a particular practice?

Senator Baker. Which documents?

Mr. Bundy. Documents which the Committee staff has provided.

Mr. Schwarz. We have them.

Senator Baker. Tell me what they are.

Mr. Schwarz. November 30, 1961, Tab -- is that Tab H or Tab 4 about the November 30, 1961, which authorizes MONGOOSE?

6 under the column "Issues and Questions" that they alleged
7 that you recall probably writing this memorandum.

8 Mr. Bundy. That is really a logical inference. The

3 Do you have an independent recollection of the meeting
4 or the encounter with President Kennedy in connection with
5 MONGOOSE?

6 Mr. Bundy. Not a specific meeting, but of the process
7 which led to this decision, yes.

8 Senator Baker. Describe for me, if you will, what
9 MONGOOSE was intended to be?

10 Mr. Bundy. Well, MONGOOSE in a general way was the
11 whole set of things to be concerned with mostly, but not only,
12 covert activities against the Communist regime in Cuba.

13 Senator Baker. The chronology also quotes the memo as
14 saying, one, we will use our available assets to go ahead

1 General Taylor, and it does say that General Lansdale
2 was to be the Chief of Operations.

3 The Chairman. I have some questions at this point, please.
4 Item 4 of this memorandum reads: "The NSC 54/12 Group
5 will be kept closely informed of activities, and will be
6 available for advice and recommendation".

7 Does this suggest to you that the regular channel was
8 supposed to operate with respect to MONGOOSE, that is to say,
9 a central role was to be played by the Special Group in
10 connection with its activities?

11 Mr. Bundy. It is a puzzling sentence to me as I read
12 it now. And I can't give you a precise answer on that. I
13 think the general answer has to be that the 54/12 Group continued
14 through this period. General Taylor was the chairman of
15 both. The overlapping of membership was extensive. And
16 I think you would get a more precise answer as to the exact
17 relation from General Taylor than I am in a position to give
18 you.

19 The Chairman. I have a very clear memory of General

22 MONGOOSE. It was further his testimony that all plans, all

3 further requirement that it go from the Special Group
4 Augmented to the Special Group. And I have no precise view

1 and the relationship tends to become closer, my relation with
2 both of them. I had known the President for many, many
3 years, and the Attorney General much more briefly.

4 I do not have any clear picture of the relationship
5 between the Attorney General and Mr. Helms. My curbstone
6 judgment would have been that it was not close.

7 Senator Baker. Based on your insight, did the Presi-
8 dent delegate to Robert Kennedy substantial aspects of Cuba
9 policy during the period we are speaking of?

8 but if he felt, as he often did, that American policy in
9 Africa, for example, was insufficiently sensitive to the aspir-
10 ations of black people in Africa, he wouldn't fire off a kick, he

4 testimony and identify exactly what words Helms might have

closely associated now. So, I see him and talk with him frequently, both about substance of matters of international development, and about the business of the Ford Foundation.

So, I have talked to him a number of times both on the telephone and face to face. The essence of the conversation is the exploration of questions raised or doubts raised about the conviction we both share, which is that no one in the Kennedy Administration, in the White House, or in the Capitol, ever gave any authorization, approval, or instruction of any kind for any effort to assassinate anyone by the CIA.

Mr. Smothers. Did you discuss with him, or did he raise with you specifically, the fact that he had received from Mr. McCone a memorandum from Mr. McCone in 1967?

Mr. Bundy. Yes, he told me that.

Mr. Smothers. Did you discuss the substance of that memorandum?

Mr. Bundy. I discussed it initially with Mr. McCone.

Mr. Smothers. Did you discuss it with Mr. McNamara?

Mr. Bundy. He mentioned it to me. I don't recall much about it.

Mr. Smothers. Did you discuss the meeting of August 10 in Secretary Rusk's office?

Mr. Bundy. That was the first discussed because the newspapers said that there had been a meeting of three, four or five of us, and the question was whether there had been such a meeting limited to three, four, or five. And we were able to satisfy ourselves that that was wrong.

Mr. Smothers. That was wrong. What do you recall to have been Mr. McNamara's reaction of the August 10 meeting?

Mr. Bundy. He didn't seem to have any that I can recall, at least I don't recall that he told me of any reaction of it.

Mr. Smothers. Do you recall the substance of his comment regarding the 1967 McCone report?

Mr. Bundy. No. I don't think he commented on it. He

You mentioned conversations with Mr. Schlesinger. Again, were those initiated by you?

Mr. Schwarz. Mr. Bundy, based upon your having had an opportunity prior to the testimony, and now again if you seek to do so, to refresh your recollection, will you recount for the Committee what happened in the summer of 1964 in connection with this matter?

Mr. Bundy. Well, it is a relatively small matter in the context of what you are discussing, but what happened in the summer of 1964 was that it came to our attention that there were relations between Cuban refugees in Cuba and people apparently associated with the Mafia. And this did not seem to be a good idea. And this was in a period in which sentiment had been steadily growing for some time against activities by Cuban refugees that were wholly outside the control and not really in the interest of the U.S., and that they should be associated with a criminal group.

And so when the matter came to the Special Group, the decision was made to refer it to the Department of Justice as a matter of internal American law enforcement. That was done.

And the Department said that it was going after the matter, which it then did, and reported back.

The reports don't give any conclusive picture of what really was going on, but they do show that the Bureau went to a number of people asking around about these matters, and as far as I know, it then faded away.

13 there. So that the question of how Castro ceased to be
14 there is left out of this set of papers. Clearly one of
15 the possibilities would be assassination, but only one of
16 them. What we are talking about here, as I read the docu-
17 ments, is a plan against the contingency that I am not reading
18 from the Parrott memorandum, against the contingency that
19 Castro would in some way or other be removed from the Cuban
20 scene. NSAM 100, whose language is indirect, nonetheless
21 indicates, to me at least, rereading it, that the President
22 wanted to know what was likely to happen if Castro were no
23 longer there. He was, in other words, trying to get a picture
24 of whether that would really change things, and if so, in
25 what way.

1 Mr. Schwarz. Just one detail that Mr. Smothers suggested
2 to me. Is NSAM 100 what the White House showed you, or is
3 it another document?

4 Mr. Bundy. No, 181. But let me be precise. I asked
5 to see the documents relating to -- from the National Security
6 files relating to August 1962. And they gave me the NSAM
7 file identified as the significant memorandum, NSAM 181.

8 Mr. Schwarz. Now, the contingency to be examined,
9 therefore, was what would happen -- would it help the U.S.,
10 that is the question, if Castro were to disappear?

11 Mr. Bundy. What would it be like if Castro were to
12 disappear? The question is open ended.

1 although you correctly point out that the President was the
2 one who wanted to know. My impression here is that whatever
3 concern we have, General Taylor or I, in the frame of this
4 language, it was precisely to insulate the President from
5 any false inference that what he was asking about was
6 assassination. It is easy to confuse the question. What
7 are things going to be like after Castro, with the other
8 question, and we were trying to focus attention on the
9 information he obviously wanted, which is, what would happen
10 if we did do this sort of thing, and not get one into the

Mr. Bundy. They wouldn't be all signed by me, not every NSMA was signed by me. But they would all be documents for which I had responsibility.

Mr. Schwarz. In connection with the MONGOOSE program, you had some dialogue about the Attorney General which was quite extensive. Let me ask you one additional question on that subject. What was the relationship personally and professionally between the Attorney General and General Maxwell Taylor?

Mr. Bundy. It was very close. I think that they first met in a hardworking sense when they were -- I think they were both members of the committee to look into what happened after the Bay of Pigs, or if the Attorney General was not a member he was certainly closely interested.

Mr. Schwarz. Do you have that in front of you, Mr. Bundy?

Mr. Bundy. Yes, I have.

Mr. Schwarz. This reflects a number of options or study that the President called for in the light of the evidence of new block activities in Cuba. Was that evidence connected with the missiles?

Mr. Bundy. Well, there was quite a buildup reported in the press and in the intelligence initially of Soviet military personnel, of Soviet surface-to-air missiles. And the crucial question was, what for and what is coming. And the Director of Central Intelligence -- who was proved in the end to be right -- was almost alone in his belief that this was going to lead to a nuclear capability in Cuba that could hit the U.S. And he raised these questions in the month of August in a number of different ways. 1 of Turkey, two, on the hard side, Items 7 and 8 , which
 2 are military possibilities of invasion or some other military
 3 possibilities in connection with Cuba. Now, is that a
 4 typical exercise that that White House, the President and
 5 yourself would go through to look at a number of options
 6 ranging from the soft to the very tough?

7 Mr. Bundy. Yes.

8 Let me say in passing that there was nothing soft about

1 action vis-a-vis Cuba. There was a so-called no invasion
 2 pledge. There was an undertaking on our side that if the
 3 offensive capabilities -- and there was an argument on what
 4 those were -- were removed, we on our side would undertake --
 5 I don't want to present this language as if it is deeply
 6 mathematically precise -- but there was an undertaking on our
 7 side that there would not be an assassination of Cuba.

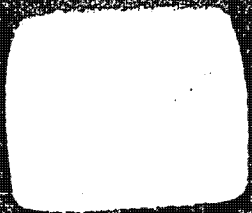
8 The Chairman. Was that ever published?

9 Mr. Bundy. Yes. If my language is inconsistent with
 10 what was published, then what was published should take
 11 precedence, because I am only trying to report that.

Mr. Bundy. Well, yes. There are a great many things that enter into my judgment about whether the President or the Attorney General would ever have done that, and I would like to say, Mr. Chairman, that the most important point I want to make, just from where I stand personally is that I find the notion that they separately, privately encouraged, ordered, arranged efforts at assassination totally inconsistent with what I knew of both of them. And as an example, I would cite -- and only one among very many -- the role played by the Attorney General in the Missile Crisis, because it was he who, most emphatically, argued against a so-called surgical air strike or any other action that would bring death upon many, in favor of the more careful approach which was eventually adopted by the President in the form of a quarantine or a blockade.

The Chairman. Well, Mr. Bundy, let me put what may be the same question a little different way.

You came to know both the President and the Attorney General rather intimately in the period of your long association with them, did you not?

Mr. Bundy. Yes, Mr. Chairman.

The Chairman. Based upon that acquaintanceship, do you believe, under any of the circumstances that occurred during that whole period, either one of them would have authorized the assassination of Fidel Castro?

Mr. Bundy. I most emphatically do not.

1 Let me make a more general point that comes at it from
2 another way.

3 If you have heard testimony that there was pressure to do
4 something about Cuba, there was. There was an effort, both from
5 the President in his style and from the Attorney General in his
6 style to keep the government active in looking for ways to
7 weaken the Cuban regime. There was. But if you, as I under-
8 stand it, and not even those who pressed the matter most closely
9 as having essentially been inspired by the White House can tell
10 you that anyone ever said to them, go and kill anyone.

11 Let me say one other thing about these two men, and that is
12 that there was something that they really wanted done, they did
13 not leave people in doubt, so that on the one hand, I would
14 say about their character, their purposes and their nature and
15 the way they confronted international affairs that I find it
16 incredible that they would have ordered or authorized explicitly
17 or implicitly an assassination of Castro. I also feel that if,
18 contrary to everything that I know about their character, they
19 had had such a decision and such a purpose, people would not
20 have been in any doubt about it.

21 The Chairman. Then have you any way to explain to the
22 Committee, or any explanation to give to the Committee, as to
23 why Mr. Helms would testify that he was under, or that he had
24 no doubts, that the Agency was fully authorized to proceed to
25 not only develop schemes, but to engage in active attempts to

2 Mr. Bundy. I have no explanation of that.

3 Senator Mondale. Part of our attempt to solve this riddle
4 of what would appear to be a record at the highest level, which
5 is at least not directly an order of an assassination plot or
6 attempt, and square it with the fact that attempts were made, is
7 to seek to understand the personalities and motivations and
8 methods of operation of people further down the chain of
9 command.

10 We have heard quite a few evaluations of Mr. Harvey as
11 a free-wheeling, James Bond kind of operator, and it has been
12 suggested through some disquiet and apprehension at higher
13 levels about the nature of his conduct. And I would -- I don't
14 know. I am beginning to have doubts about Mr. Helms whom I
15 have always admired. There is, for example, a memorandum that
16 is in the record to Mr. Rusk in response to a memo which the
17 Secretary wrote Mr. Helms following an article appearing in
18 some Cuban newspaper charging that the Mafia had been hired and
19 used by the CIA to assassinate Castro, in which Helms specifi-
20 cally and categorically denies flat out that any such relation-
21 ship existed when in fact it did and when in fact Mr. Helms was
22 part of it.

23 Now, how do we sort this out? Is Mr. Helms someone who
24 might have, on his own, gone beyond the authority conferred
25 upon him by persons higher up?

7 occurred. We know that Mr. Helms was a part of it. We have

10 document here -- well, that was Cubella -- and then we have a
11 memo from Helms to Rusk which, in Minnesota language looks
12 like a lie. Now, I just don't know. Maybe there are other
13 explanations.

14 The Chairman. The memo to Rusk had to do with Cubella
15 rather than the Mafia.

16 Senator Mondale. Is that it? It was not the Mafia?

17 Mr. Schwarz. It was Cubella, except if you just substitute
18 Cubella for the word Mafia.

19 The Chairman. What you said otherwise is correct.

21 Cubella, wasn't he? And he knew that, and this memo said no.

22 Is there a plausible explanation?

2 Mr. Madigan. I think Helms claimed that Cubella is in

4 The Chairman. Well, I believe rather than speculate, we

7 Senator Mondale. Well, then I will stand corrected.

8 Senator Hart of Michigan. Would you yield?

9 I want to make the same record note that I suspend the

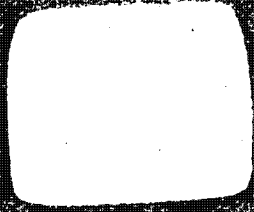
The Chairman. We seem to have a developing problem for reasons unexplained with the Justice Department. I have already mentioned one aspect of that problem, in connection with the failure of the Department to supply most of the material that we have requested, though that request was put to the Department two months ago, and it has been decided already by the Committee that Mr. Levy and Mr. Kelley should be brought before the Committee in the hopes that these delays can be overcome.

The first question before the Committee is when that can be done. It is suggested that the Attorney General has Tuesday morning available. If it is all right with the Committee, I would like to schedule his appearance, together with that of Mr. Kelley, for Tuesday morning.

Senator Baker. Mr. Chairman, I don't mean to intrude my personal convenience into this consideration unduly, but if the Attorney General could do it at Tuesday noon, say, it would help me. I have a commitment in Tennessee Monday night. If I catch the Tuesday morning plane I can't get here until 11:50.

If that's not possible, I will cancel Monday.

The Chairman. This is procedural in character, so it is not altogether important that every member be present. I think that from the standpoint of this Committee schedule, Tuesday morning, the Attorney General and Mr. Kelley would be good, would it not?

8 can be very specific to tell the Committee the exact status of
9 that situation, how we have been informed and if we can rely on
10 that information as being authoritative.

11 Mr. Elliff. Yesterday morning at 9:00 o'clock or shortly
12 thereafter, I received a phone call from the FBI's liaison with
13 this Committee with respect to a series of interviews that had
14 been arranged with the Bureau some relating to the Huston Plan,
15 some relating to Martin Luther King matters. I was informed that
16 I had to address this request to the Justice Department in order
17 to secure approval for these staff interviews.

18 I then called our liaison in the Justice Department,
19 Special Counsel William O'Conner, and he told me I might as
20 well submit these requests in writing, because the Justice
21 Department would take at least ten days to give us an answer
22 on these requests and he didn't know what the answer was going
23 to be.

24 I then explored with him what some of the reasons might be

1 explanation that he gave me verbally was that the fact that
 2 the Committee had notified the Department in its letter of
 3 June 27th that certain cases that we were investigating were
 4 abuse cases meant that any interviews that would be conducted
 5 in connection with those matters would be considered by the
 6 Department to be demand interviews, and therefore this brought
 7 into play the provisions of the Federal Regulations which
 8 require the Attorney General's approval.

9 Then the question as to whether the Attorney General would
 10 approve or not involved two issues. First was that since we
 11 had indicated the likelihood of an abuse in a particular area
 12 that the Department itself would have to consider whether it
 13 should institute a criminal investigation of that matter, and
 14 then, if so, whether our interview would interfere with that
 15 ongoing criminal investigation.

16 And second, that the Department considered that any inter-
 17 views undertaken by the Committee in such cases might inadver-
 18 tently immunize the subject of the interview, and he referred
 19 generally to some cases and we have attempted to do legal
 20 research on those cases and find this to be a very shaky position
 21 but they have good lawyers over there and if they want to come

1 that he did anticipate that subpoenas would be required
2 in every instance and this position is very difficult for us to
3 accept because interviews, the low-key interview in the non-
4 pressure situation is an opportunity to elicit information that
5 is not matched by the formal subpoena situation, and to be
6 able to proceed initially by interview and then confirm, under
7 oath, via subpoena, is just absolutely essential for an effective
8 investigation. So this is where we stand on this issue.

9 We later received a letter pertaining to an earlier
10 request for interviews relating to FBI COINTELPRO disruptive
11 activities where we had asked for certain interviews, and this
12 letter did not go into specifics, but merely stated that there
13 were problems that would have to be resolved, that the charac-
14 terization of an area of the Committee inquiry as abuse might
15 significantly alter arrangements of access to witnesses who
16 are present employees of the Department.

17 The Chairman. In other words, the thrust of all of this
18 is that the more serious the nature of the inquiry, the more

1 They have given us a good many documents. They
2 have not given us the documents on the controversial matters.
3 They've given us plenty of documentation on less controversial
4 matters.

5 The Chairman. I think it is ironic that the resistance we
6 get from the Justice Department is so much more substantial than
7 the resistance we have gotten from the CIA.

8 Senator Baker. That's not necessarily so. I agree with
9 you the resistance is unfortunate and inappropriate, but I
10 can think of a request for documentation from the CIA that is
11 now more than a month old and they haven't had the good grace
12 to tell us no. They have told us nothing.

13 The Chairman. But on the whole we've gotten a greater
14 measure of cooperation from the CIA.

1 There is this troublesome dictum in U.S. vs. Nixon about
2 what might be nondiscoverable, all of which seems to bear on
3 sort of foreign policy matters.

4 Am I correct -- I think we're going to hear a lot about
5 that -- but am I correct in reading that decision that it
6 really almost stands wholly that they have the duty to
7 produce all of the documentation and that case holds for that
8 proposition, so that in our CIA matters, while they might raise
9 some of this dictum, the FBI has no such defense, unless we're
10 really trodding on those same grounds.

11 Mr. Epstein. Of course, there is another issue in the
12 Bureau materials, because we're on the issue of investigative
13 files, which has never been really litigated, and that

2 Now what I would like is, while we finish this cycle on
3 assassinations, that we include among our studies of alleged
4 assassinations this matter and we request the documentation, of
5 all appropriate documents, under the category of assassination.

6 Mr. Schwarz. Senator, when that document came to our
7 attention, we questioned a person who expands upon the allega-
8 tions contained in the documents. I wrote a letter to the
9 White House and the CIA. We wanted forthwith to receive
10 copies of all such documents relating to the passage of weapons.
11 We have had no response from the CIA.

12 Mr. Hills, we met with in the White House a week ago
13 Tuesday or Wednesday, and I said we must have the documents and
14 he said you cannot have them until you have the briefing on
15 Chila, because we refuse to accept this as an assassination
16 plan.

17 The Chairman. May I make this suggestion, Senator

4 Senator Schweiker. I think, Mr. Chairman, if we don't
5 finish it by then, we never will.

6 The Chairman. We never will.

7 I think we should look into this assassination, it is an
8 assassination. I think it's part of our responsibility to
9 look into it. But it is not an assassination, whatever the

19 Senator Mondale. It is significant because if we accept
20 their interpretation that it is not assassination, then we
21 avoid an understanding that we had that these documents, all
22 supposed to be available, then we get into a discovery problem.

23 In other words, I know what we're getting at, and I would
24 guess that we should proceed as rapidly as possible, but we
25 shouldn't hold up the cycle of --

2 along the same lines, and that is why I don't want to see it
3 cloud this issue, and that is the Glomar Explorer, stopped by
4 the NLRB proceeding was shown to have stopped in Chile just
5 about a week or so before Allende was killed, just by coincidence
6 for mechanical repairs. I would like to find out that one,
7 too.

8 But this is a whole new thing. This puts us into the
9 Chile thing. Because I'm just as interested as you are. I
10 don't see that it hurts anything to put it in a Phase II
11 proposition with Chile.

12 The Chairman. And Fritz, we can say that the Committee
13 regards it in the category of assassination, but we can differ-
14 entiate it from the initial report, which does deal with

18 reply reminds me, you say that we are going to conclude assassina-

23 are going to present, once we open the doors, we've got to know

25 ourselves in at the moment to a written report, as we leave town.

Senator Baker. I agree with you 100 percent.

The Chairman. This Committee has got to get its business done and I know the purpose of the delay downtown is to make it as difficult as possible for us to cope with our work.  7 question: do you have open hearings? Do you go to a closed

5 questions.

6 Mr. Smothers. Well, since we don't know what was in the
7 file --

8 Mr. Bundy. Well, I thought I said the file was a file of
9 National Security Action memoranda, a file which you already
10 have here.

11 Mr. Smothers. Relating to August, 1962?

12 Mr. Bundy. Uh-huh.

13 Mr. Smothers. That's all I have, Mr. Chairman.

14 Mr. Schwarz. On the Trujillo matter --

15 Mr. Bundy. Sure.

16 Mr. Schwarz. You know Mr. Trujillo was killed. Did you
17 know or do you know that the persons who killed him had
18 obtained some weapons from the United States?

19 Mr. Bundy. I did not know, and do not now know, of my
20 own knowledge that that was the case.

21 I did know, or at least I believe I must have been on
22 notice because of documents again that you have shown me, that
23 weapons by a decision of the Special Group in early January
24 had been or were being passed to Dominican dissidents.

25 Mr. Schwarz. Were you involved in the sending of a telegram

1 to the Dominican Republic, either two or three days prior to the
2 actual assassination of Mr. Trujillo?

3 Mr. Bundy. I have no recollection of it, and when I saw
4 those telegrams in discussions with your staff, they stirred no
5 recollection on my part.

6 Mr. Schwarz. Is it fair to state that Mr. Richard Goodwin
7 is the best witness on those subjects from the White House for
8 that period of time?

9 Mr. Bundy. It appears that way to me, although that
10 appears more from the fact that important documents seem to
11 have been addressed to him than because of my own recollection
12 that he was interested in the matters and because of my phone
13 conversation with him, he showed a considerable familiarity
14 with events in the Dominican Republic, political events during
15 that spring.

16 Mr. Schwarz. Well, you got a memo from Mr. Bissell in
17 February, 17th February '61. It is Tab R of the Trujillo
18 Book 1 of 2, in which you were informed that the dissidents
19 had been told by the United States that it was prepared to
20 provide them with a limited supply of arms and equipment.

21 When you got such information, did it trigger in your mind
22 anything to the effect of, let's be concerned about how they're
23 going to use those weapons, or did you just accept the informa-
24 tion and do nothing about it?

25 Mr. Bundy. It is clear that the information was sent to

1 me and it was clear, in that sense, that I had become responsi-
2 ble for knowing what was in the document, but I have to say that
3 as I reread it I have no recollection that I ever, in fact, did
4 read it at the time. Whether that was because of the flow, the
5 very heavy flow of other documents or because I passed it to
6 someone else or because I just simply didn't get to it, I cannot
7 tell you, but I have no recollection that I saw it.

8 Mr. Schwarz. You did make a request for a briefing paper?

9 Mr. Bundy. It must have been done, and it was either done
10 in my name or I did it.

11 Mr. Schwarz. So you're not capable -- you don't remember
12 it. Are you capable of making a comment on my question, which
13 was having received information that arms had been supplied --

14 Mr. Bundy. Having that information on my desk, anyway.

15 Mr. Schwarz. Okay.

16 In the light of hindsight, should persons in your position
17 when they receive such information inquire into the purpose for
18 which the arms are to be used?

19 Mr. Bundy. Yes, I would -- and my own guess on this, and
20 it's not much better than that, is that the decision which had
21 been taken only a week before the new Administration came in,
22 in the Special Group, was partly reviewed in some fashion, with
23 the Special Group as reconstituted after the change in
24 Administration. So I would have to say that I suppose I knew
25 that weapons were being introduced into the Dominican Republic

1 and I would have to add that I did not, or I have no recollection
2 and I think I would recollect it, if I had engaged in a careful
3 inquiry to find out just what, who, when where and so on did
4 not do that, and I think -- you ask in hindsight, I think it
5 would clearly be important to have that kind of understanding,
6 because as I understand the evidence that has now been developed,
7 there was a level of communication and connection with the
8 plotters in the Dominican Republic which exceeded what political
9 authority appears to have expected or believed was going on.

10 Mr. Schwarz. Would you agree with one further point,
11 that it is very difficult for the United States to control
12 events once it has made a decision to cooperate with dissident
13 elements, and in particular once it's made a decision to
14 cooperate with dissident elements by providing them with arms?

15 Mr. Bundy. I think that -- one thing, I don't want to
16 generalize here, but I think -- I would agree with the generali-
17 zation, let me put it that way, if I could add that in the case
18 of the Dominican Republic, I think one has also to recognize
19 retrospectively that there was no way to have any communication
20 with dissidents that would not involve recognition that, if you
21 propose to be an effective dissident in that country under that
22 ruler, you would probably be contemplating fairly violent
23 action.

24 Mr. Schwarz. I have nothing further on Trujillo.

25 One question of Vietnam.

1 You were involved in the question of the possible coup in
2 Vietnam that actually took place?

3 Mr. Bundy: Yes.

4 Mr. Schwarz: And you were substantially involved in that
5 as a matter of personal --

6 Mr. Bundy: I was working closely with the President and
7 was probably the draftsman under his instruction of some of
8 the cables that went out.

9 Mr. Schwarz: Now, Diem was killed. It does not appear to
10 me from the record that the United States wanted him killed.
11 Is that fair?

12 Mr. Bundy: That is correct.

13 Mr. Schwarz: But the United States did want him deposed
14 if a coup could be successful? Is that correct?

15 Mr. Bundy: The United States really had two views. Right
16 up to the end, the United States hoped, hoped against hope, as
17 it became more and more difficult to communicate with Diem,
18 that he would see the, or come to share the kinds of argument,
19 that were made to him, primarily by Ambassador Lodge, and that
20 a change in his government and a lower, much lower, role for
21 his brother and sister-in-law would assist him in recapturing
22 public confidence. That was always the preferred solution.

23 As prospects for that became more and more dim, the United
24 States did come to take the view that there might be no alter-
25 native to a coup, and it certainly had the view that if there

1 was going to be a coup, I believe the language somewhere in
2 one of the cables is that it was in the interests of the United
3 States that it should succeed.

4 Mr. Schwarz. Now, on the day of the coup, Ambassador
5 Lodge told Mr. Diem that he would provide help to get him out
6 of the country and do so by airplane, but he couldn't have the
7 plane for twenty-four hours. A, did you know of the twenty-four
8 hour point?

9 Mr. Bundy. I don't remember that we did.

10 Mr. Schwarz. B, don't you find it incomprehensible that
11 the United States was not able to supply an airplane for
12 twenty-four hours?

13 Mr. Bundy. I don't really know because it depends on
14 where the plane was going to go, what kind of plane. I don't
15 think I'm competent to answer that question.

16 What occurs to me is, there were lots of other ways of
17 offering asylum for a twenty-four hour period, and I don't
18 think I really find that a very significant point.

19 The Chairman. Any further questions?

20 If there are no further questions, I want to thank you
21 for your testimony, it has been long, a very long morning, and
22 it has been very helpful testimony. We appreciate it very
23 much.

24 Mr. Bundy. And I am thankful to you, Mr. Chairman.

25 Mr. Chairman, if it is not inappropriate and there is no
