⑤ 7- "Associated press outlined 6 July 1959, Havana, carried story about Wilson who said he had begun a seven day hunger strike to protest his arrest and had to be fed intravenously at Cuba's national Police Hospital. Although police denied Wilson was on a hunger strike, a hospital intern said that he was suffering from physical exhaustion brought on by his refusal to eat. According to a 16 July 1959 Havana press report, Wilson's wife, a Chilean named Eliana Bronfman, said Wilson had received a law degree from Oxford University and had fought in the International Brigade during the Spanish Civil War.

⑥ "On 18 August 1959 Wilson walked into the U.S. Consulate, Kingston, Jamaica, and said he was a journalist who had just been released after 54 days detention in Habana prison. On 21 August 1959 the U.S. Consulate in Kingston issued Wilson a single entry non-immigrant visa. He was carrying British passport 147356 issued in Havana 14 August in the name of John Wilson. He was attempting to get air passage to Miami in order to sell his story to the Miami.

2. "Wilson may be summarized as a person of intelligence, but so erratic as to be considered mentally unbalanced at times. He is a soldier of fortune, having begun his career in July 1936 when he left Oxford to fight in Spain. He has been accused of working for the intelligence services of several countries, and he himself has claimed to have acted on behalf of different intelligence services. He has been consistently anti-United States."

and had been here since. He is planning, however, to return to Santiago within the next two weeks, largely because he is unable to support himself here any longer since the Chilean Government has refused permission for the remittance of funds he holds in Santiago. Mr. Wilson gave his present address as 35 Craven Terrace, Lancaster Gate, London, W.2, telephone Paddington 9276.

Comment: "This is the second time Wilson has approached me to show an interest in intelligence matters. The first time was shortly after President Kennedy was assassinated, when he said that he had been imprisoned in Havana by Castro in 1959. He alleged that while in ~~Havana~~ he was in prison, meals for a fellow-prisoner, a former gambling czar in Havana with early associations with the Capone gang, had been brought to the prison by a man who identified himself as "Ruby" and who bore a physical resemblance to the man being tried for Oswald's murder."
