significance: first insight into OBT - all previous had been on G-2. which had been directed mainly at Cub. exiles.

learned OBT more sophisticated than ever suspected.

first hand info on OBT & it was accurate - some identities & intell. roles confirmed.

Dictionary of Cuban Intell terms including phrases used to ID activities & tools of trade.

was used subsequently to recruit other Cubans - doesn't recall effectiveness. good indication of bona fides

✓ first met ^{A-1} in summer 64.

✓ assigned to hand-hold 1E maintain contact to see he is accommodated & providing companionship & escort duty.

✓ 2. debriefing.
