Bosch was one of many critical of CIA policy & personnel following Bay of Pigs. However, in March 1962, WAVE requested a POA on Bosch, advising he was "cooperative and secure." To be utilized as General Coordinator of Eulio Dugue group. POA granted on 6 March 1962. Given polygraph in May 1962 & came out clean. His clearance was cancelled in Nov. 1962.

Bosch aligns himself with individuals and organizations that are currently involved in operations against Cuba, usually serving as General Coordinator & takes responsibility for securing financial backing.

Cuban Ambassador Norberto Hernandez Gurbel reported receiving bomb in large manila envelope bearing return address of Dr. Gustavo A. Vollmer.

WK Scarlet/1, former WK Scarlet chief, is security consultant to Vollmer + has retained WK Scarlet/3 who is operating a commercial investigation service, to determine who used Vollmer's name. WK Scarlet/3 maintains contacts with Orlando Bosch.
