After many of DRE members came to Miami, they were trained & infiltrated back into Cuba for intelligence purposes. After Bay of Pigs, DRE members were used as political action groups throughout the Western Hemisphere.

DRE conceived, created & funded by Agency in 1960 & terminated in 1966. Outgrowth of activist student group in Cuba which fought against Batista & later Castro. Many leaders exiled in 1960, trained & infiltrated into Cuba by the Agency in 1960 where they operated through the Bay of Pigs invasion. Set up primarily as a psych warfare outfit, DRE also given large amount of paramilitary aid. After Apr. 1961, DRE engaged in independent operations on an increasing basis & contact with Agency gradually declined. This largely due to a cutback in Agency funding for Cuban anti-Castro organizations. After January 1965, Agency contact with DRE personnel was limited to Juan Manuel Salvat and Fernando Garcia Chacon.
