DC - SR9: 1956-1960

Levy stated that he never heard of CITO until 1963. He says that SR 9 was a small office & had CITO's name arisen, he would have known about it.

SR 9 was a special operations office involved in running clandestine operations in Soviet Union. During those years, SR 9 had only 1 or 2 assets w/ the Soviet Union. These individuals were Soviets.

SR 10 - designed to utilize non-Soviet foreign travelers w/ USSR to try to recruit Soviet or support clandestine activities.

Levy stated that SR 9 knew everything that SR 10 was doing, & he would've known about Oswald if Oswald worked for SR 10. Only exception to this was when SR 10 was doing something directly w/ which was not at all important. Anything important SR 10 would contact SR 9 for assistance. Levy gave example of when SR 10 was trying to locate people in Soviet Union for a long time.

Levy reviewed the 11/05/63 Casbin memo, & said he had never seen it before. He added that Agency could not possibly have debriefed everyone of the thousands of people who traveled w/ USSR. Levy stated that CITO wouldn't have talked to CITO because it was apparent that he

- was w/ SR 9 from 1953-63.
Deputy chief from SR 9 from ~~1959~~¹⁹⁶⁰-62.

- general function of SR 9 was to run clandestine operations in Soviet Union. He ran the Penkovsky case.

Kisevalter has known Alexis Davison for many years. He assisted the agency in that case, but "absolutely had no contact w/ LHO on behalf of CIA."

Davison's role in Penkovsky was very limited. He was virtually a single occasion asset.

Kisevalter said that, as deputy chief of SR 9, he definitely would've known about LHO if he had been connected with CIA. It would've been impossible for any clandestine ops to have been run in Soviet Union w/ him (Kisevalter) having known about it.

In 1963, as assistant to Howard Osborne, chief of SR, he conducted a review of every clandestine operation ever run in Soviet Union. LHO was never involved.

SR-10 - used legal tradecraft as a means of obtaining info.

He never heard LHO's name mentioned anywhere prior to assassination.

LHO was not an agent, asset, or source of info for CIA.

LHO would not have been used by SR 10 because they were looking for clean cut Americans who spoke Russian. Helms had to sign off on any of these.

He pointed out that SR 9's usually involved clandestine ops involving the use of foreigners.

If LHO had been used by SR 10, D.C. would've known about it. When D.C. heard that LHO killed JFK, the name "rang no bells."

He had never seen the Casper memo before.

to work in American Legal Traveler
program, Sawicki would've known about it.
Sawicki says he interviewed every
person who was involved in the
program.

He never saw Casarin memo before
& never discussed LHO with him.

SR 10 was primarily interested
in personalities - people who were
potentially spies for U.S.

He never spoke to Priscilla J.
McMillan & she was not in American
Traveler program.
