Recontact with PCI AL DARGIS and review of Bureau indices reflect the individual described by PCI as FELIX GOLINO, Patterson, La., is identical with FELICE GOLINO, who is currently the subject of an investigation entitled, "FELICE GOLINO, AR," initial report of SA LELAND A. LYNN, New Orleans, 11/14/61, submitted.

GOLINO publicly admits that he is a friend of CARLOS MARCELLO and owns an interest in the Town & Country Motel, Shreveport, La., and the Holiday Inn, New Orleans, La., of which MARCELLO is suspected of having interest. GOLINO is a part-owner of the Sea Shrimp Company, Patterson, La. GOLINO visited MARCELLO during the time that he was deported to Guatemala.

Efforts will be continued to determine if there are any facts to the rumor that FELICE GOLINO assisted MARCELLO in returning to the United States.
