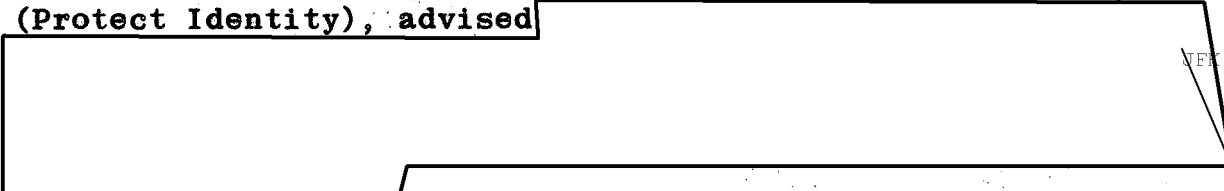
On 3/29/63 the records of the Statler-Hilton Hotel were checked for the period from 3/17/56 until 10/16/62 with it being noted that WESTBROOK was a guest at this hotel on 22 separate occasions.

On 4/3/63 PCI GEORGE FREDERICK RECHENBERG (Protect Identity) advised that when WESTBROOK was in Dallas, Texas, during the late 1940's, he was a close associate of STONE and a JOHNNIE EDGAR LANE, FBI #390267. RECHENBERG stated that LANE at that time operated a horse book in Dallas but has since moved to Las Vegas, Nevada, where he now operates the Hollywood Horse Book. PCI stated that WESTBROOK spends considerable time at LANE's place in Las Vegas and also makes numerous trips to Dallas, Texas, to visit STONE.

On 4/15/63 MRS. WESTBROOK advised SA's of the Los Angeles Division that JOHN WESTBROOK had departed Los Angeles for Las Vegas, Nevada, on 4/7/63 where he met JOHN STONE. WESTBROOK returned to Burbank, California, on 4/10/63. MRS. WESTBROOK was unaware of WESTBROOK's business transactions in Las Vegas, Nevada; however she assumed it is in connection with his gambling interests.
