ADMINISTRATIVE (CON'T):

FAUGNO dating from the time that FAUGNO was involved in union activities in the International Longshoremen's Association. Informant believes that some of the money that FAUGNO invests in shylocking and other enterprises comes from PROVENZANO and Local 560 funds. FAUGNO, according to the informant, is presently engaged in shylocking, numbers and fencing stolen goods.

On 12/27/62, NK 2181-C advised that HAROLD KONIGSBERG became involved in a brawl at a crap game in the Marion section of Jersey City during the weekend of 12/15 - 16/62, and KONIGSBERG stabbed one FRANK ROMEO who was running the game for ARMAND FAUGNO. As a result of all this, FAUGNO went looking for KONIGSBERG and after several days, located him and shot him with a shot gun. As a result of this shooting, a meeting was held to straighten the affair out. ANTHONY PROVENZANO along with JOSEPH ARTHUR ZICARELLI and ANGELO DE CARLO, both of whom are well-known hoodlums in the New Jersey area, met with FAUGNO.

On 1/17/63, PCI ANTHONY JOHN VIOLA stated that while he was a member of Local 560, IBT, ANTHONY "Three Fingers" CASTELLITO, an officer of that Local, was reported missing. VIOLA stated that of all the reasons expressed for the disappearance of CASTELLITO the one that was popularly accepted was the one that CASTELLITO and PROVENZANO were in violent disagreement over PROVENZANO's insistence that welfare money be used for shylocking and other illegal activities. CASTELLITO as Secretary-Treasurer of Local 560 maintained the position that PROVENZANO should seek other sources of revenue for his investments and when it became apparent that CASTELLITO was going to maintain this position, PROVENZANO had him killed.
