It was indicated that Sierra wanted to establish
a fishing company in Haiti which would be used as a
screen for operations against communists in Cuba. (S) (T)

(S) According to Bureau source 6, Paulino Sierra had
indicated an interest in financing an exile movement
against the Cuban Government in 1963. Bureau Source 6 (S)
