INVESTIGATION OUTLINED IN REFERENCED TELETYPE APPEARS TO HAVE CONSIDERABLE POTENTIAL, AND THE BUREAU AGREES WITH COURSE OF ACTION OUTLINED BY SAN FRANCISCO, WHICH INCLUDES AGRESSIVE AND IMAGINATIVE PURSUIT OF THIS CASE. BUREAU ALSO AGREES THAT [REDACTED] HAS CONSIDERABLE POTENTIAL AS A PARTICIPANT IN TECIP AND PARTICULARLY IN CONNECTION WITH THIS INVESTIGATION.
