DURING RECENT CONTACTS WITH [REDACTED], SHE HAD ADVISED SHE IS FREQUENTLY A PARTY TO CONVERSATIONS WHEREIN AMARENA, ALADENA "JIMMY THE WEASEL" FRATIANNO AND OTHER SUBJECTS DISCUSS THEIR CRIMINAL ACTIVITIES AND ARRANGE MEETINGS WITH ONE ANOTHER IN FURTHERANCE OF THEIR ACTIVITIES. [REDACTED] INDICATES THESE DISCUSSIONS TO WHICH HE IS A PARTY OCCUR AT AMARENA'S PLACE OF BUSINESS (SAL'S ESPRESSO CAFFE, SAN FRANCISCO) AND AT [REDACTED] APARTMENT 39 FAIR OAKS, APT. 204, SAN FRANCISCO. [REDACTED] HAS ADVISED SHE WILL COOPERATE IN THIS INVESTIGATION TO THE EXTENT OF ALLOWING THIS OFFICE TO INSTALL EQUIPMENT IN HER APARTMENT TO RECORD HER CONVERSATIONS WITH AMARENA, FRATIANNO AND OTHER SUBJECTS. [REDACTED] HAS AGREED TO TESTIFY.

DURING RECENT CONTACTS WITH KOTOSKE AND SFSF ATTORNEY JOHN EMERSON, BOTH AGREE THAT [REDACTED] CONVERSATIONS WITH SUBJECTS SHOULD BE RECORDED TO PRESERVE THEM IN VIEW OF THEIR OBVIOUS EVIDENTIARY VALUE. ON JUNE 10, 1976, EMERSON ADVISED THAT HE HAD REVIEWED THE MATTER AND FEELS ENTRAPMENT PRESENTS NO PROBLEM.

VIA SAN FRANCISCO TELCALL, SAN FRANCISCO REQUESTED EMERGENCY AUTHORITY OF THE BUREAU BE GRANTED TO RECORD CONVERSATIONS [REDACTED] MAY HAVE WITH SUBJECTS AT HER SAN FRANCISCO APARTMENT. THE BUREAU ADVISED BY RETURN TELCALL THAT EMERGENCY AUTHORITY COULD NOT BE GRANTED IN THIS CASE BECAUSE THERE WERE NO COMPELLING CIRCUMSTANCES, (I. E., IMMEDIATE DANGER TO A VICTIM), FOR WHICH BUREAU EMERGENCY AUTHORITY WAS DESIGNED.

IN VIEW OF THE FOREGOING, THE BUREAU IS REQUESTED TO OBTAIN 30-DAY DEPARTMENTAL APPROVAL FOR INSTALLATION OF RECORDING EQUIPMENT IN [REDACTED] APARTMENT, 39 FAIR OAKS APT. 204, SAN FRANCISCO, TO RECORD HER CONVERSATIONS WITH SUBJECTS SALVATORE AMARENA, ALADENA FRATIANNIO AND OTHERS.
