MSY PRISCILLA HOUSTON, residing at 184 East 62nd Street, NYC, has advised that her roommate, MARJORIE MC KEENE, aka., Plico, brought a friend, DANIEL WELSH, to the apartment for a short stay. HOUSTON learned from WELSH, a former chorus girl from the Chez Paree, that she was the favored mistress of subject, who was currently having an affair with PHYLLIS MC GUIRE of the MC GUIRE sisters, a singing trio.

According to MILLER, subject is in NY staying at the Hampshire House, using an alias other than he usually uses, for purposes of his courtship with RO (SHE). MILLER informed HOUSTON, the subject was the aliases, STAN, CHESTER, MOONEY, PEARL, and SHERMAN. He is accompanied by one 'ALICE' (probably GENE FARMER), a bodyguard (known associate) and is in contact with CHARLES TOURNE, aka., Charles White, and JIMMY DINO.

According to HOUSTON, MILLER is in daily contact with DINO who is also a friend of subject. MILLER advised HOUSTON that DINO has business meetings in his room (21610) at the Savoy Hilton Hotel in NY.

It was determined through PCI SOL GOODMAN that TOURNE is currently staying at the Essex House in NY.

The report of SA WILLIAM J. DUFOY, dated 12/27/57, at Miami, captioned, 'CHARLES TOURNE, was., MI, Miami file 62-106, Bufile 92-2939, reflects, on page 21, a JAMES DINO as an associate of TOURNE. Miami is requested to obtain and furnish the NYO with background, photo, and descriptive data re DINO.

According to PCI TOURNE, MILLER's address in Chicago is 520 North Rush Street, and she is described as about 35 (possible DOB 6/7/33), 5'4", brown hair, green eyes, very pretty. Subject, who allegedly has a net worth of \$100,000 in her during the past years, is named by MILLER as Chicago's number 2 man, who is to take over when the number 1 man is sent away on income tax violations. MILLER drives a Renault car, serial number 3508547 and has an Illinois license 1N-430-5323-0768. A voter's stub for MILLER reflects an address c/o G. B. O'ROURKE, 2630 1/2 North Magnificent, Los Angeles.

It is noted that on the basis of information furnished by PCI HOUSTON, NY 98-778 was instituted on 10/10/58, and is in a position to cover activities at JAMES DINO's current residence in the Savoy Hilton Hotel.

Chicago, Miami, and Los Angeles are requested to determine background data re MILLER in a discreet manner so as not to endanger PCI HOUSTON.
