ReWFOairtel and LHM dated 3/9/66 and WFO airtel dated 3/31/66 both of which were captioned "ANTI-FIDEL CASTRO ACTIVITIES; IS-CUBA."

WF T-1 mentioned in the enclosure is ~~WFO~~ PSI CARLOS PEDROSA TORO who furnished his information to SA JAMES M. COADY. WF T-2 is ENRIQUE LINDNER, further described in the LHM, who requested his identity be concealed.

Indices of WFO negative re information identifiable with EDWARD BAEZ, and LOS PINOS NUEVOS. Indices also negative re information identifiable with the individuals mentioned in the LHM other than that information which is already in possession of the Bureau and Miami.

WFO is taking no further action in instant matter.
