On July 23, 1966, Mr. STANLEY SCHACHTER, U.S. Customs Agent, Miami, advised that agency is conducting an intensive investigation concerning this matter and is maintaining around-the-clock surveillances on boats known to have been used by the 30th of November and Comandos-L organizations. He said that Customs will maintain around-the-clock surveillances until after July 26, 1966.
