NORMA SEID, 39 Palm Avenue, Palm Island, Miami Beach, Fla., wife of AL SEID, associate of JOSEPH MEROLA, refused to be interviewed by FBI. FIA

JOAN BARBARA WITT, 7510 Center Bay Drive, North Bay Village, girlfriend of HERKIE STYLES, interviewed. She denied knowing MEROLA or ever seeing jewelry this case. FIA

MM 722-C endeavoring to learn additional information about disposition of jewelry by MEROLA.

GEORGE H. TREADWELL, Jr., one of original sources of information re "PAT and MIKE," determined to now be residing Memphis, Tenn., and leads set out for his reinterview. ADALBERT BUCHWALD, who shares office space with JOSEPH MEROLA, and MEROLA's attorney, MURRAY GOODMAN, interviewed. MURRAY GOLDMAN and MEROLA business associates in Pan American Enterprises, Inc., 420 Lincoln Road, Miami Beach. BUCHWALD formerly jewelry store owner, Miami Beach, had no information this case, nor had he observed jewelry in possession of MEROLA.

Close liaison maintained with Homicide Division, Dade Co. Department of Public Safety, in connection their investigation of JOSEPH DI MARE murder.

Liaison also maintained with Hallandale PD.

Miami continuing its investigation of MEROLA.
