JOAN BARBARA WITT, 7510 Center Bay Drive, North Bay Village, girlfriend of HERKIE STYLES, interviewed. She denied knowing MEROLA or ever seeing jewelry this case.

MM 722-C endeavoring to learn additional information about disposition of jewelry by MEROLA.

GEORGE H. TREADWELL, Jr., one of original sources of information re "PAT and MIKE," determined to now be residing Memphis, Tenn., and leads set out for his reinterview. ADALBERT BUCHWALD, who shares office space with JOSEPH MEROLA, and MEROLA's attorney, MURRAY GOODMAN, interviewed. MURRAY GOLDMAN and MEROLA business associates in Pan American Enterprises, Inc., 420 Lincoln Road, Miami Beach. BUCHWALD formerly jewelry store owner, Miami Beach, had no information this case, nor had he observed jewelry in possession of MEROLA.
