A review of this account reflects that there were weekly deposits in the amount of \$59.25 and all checks written were in the amounts of less than \$30.00 and all were cashed at food stores or for what appeared to be normal household expenses.

UACB, no further review of subject or his wife's bank account will be made on a regular basis but spot checks of his account will be made and a thorough review if information is received from sources indicating that the subject has received a substantial amount of money.

The Agents who observed subject to participate in a picket line on January 22, 1962, were ALESIO SAVIOLA and ANTHONY D. LEONE.

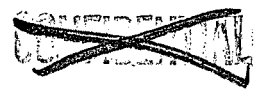
