CARLOS PRIO SOCARRAS
INTERNAL SECURITY-CUBA

On September 13, 1962, a confidential informant, who has furnished reliable information in the past, advised that on that date, Carlos Prio Socarras, former President of Cuba, contacted Rene Fiallo, of the Dominican Embassy, Washington, D. C. Prio stated that he was going to be in Washington during the following week, and in view of the aggravated Cuban problem, was thinking of issuing a statement in Washington which he desired to have Fiallo translate. Fiallo, after some reluctance, stated that he would do what he could for democracy, but that he had intended to leave Washington on the following Sunday to spend a week in the Dominican Republic. However, he agreed to change his travel reservations so as to leave Washington on Saturday, September 15, and to pass through Miami where he was to be met by Prio. (S)

According to the June, 1962 issue of the "Diplomatic List," published by the United States Department of State, Rene Fiallo is Minister-Counselor of the Dominican Embassy. (S)
