4. REPORT OF FINDINGS

- 37 (AGENCY) On 13 November 1958, the files of FBI, New York, New York, were consulted concerning Fred Jerome, an associate of SUBJECT and the following information was extracted from bureau file 105-41624, dated 24 September 1958:

Frederick Louis Jerome resides at 320 Second Avenue, New York City and is a student at City College of New York. On 6 June 1958 Jerome was in contact with William Z. Foster regarding formation of a new youth group. The FBI informant furnished information that Jerome contacted youth groups between New York and California concerning the Communist Party. Jerome was in contact with an employee of the Soviet Embassy in April 1957. (S)

Jerome's father, Victor Jeremy Jerome was one of the Communist Party leaders convicted in 1953 for violation of the Smith Act of 1940.
