AMERICAN DEFECTORS IN BAUTZEN (ROZ).

1. RA 53117942 Raymond H. HUTTO, AWOL wef 28 Jun 54.  
Source could give no new information about the a/n defector.
2. US 51113516 Arthur BOYD, AWOL wef 9 Nov 53.  
Source confirmed that the a/n lives outside BAUTZEN in SINGWITZ and wishes to move back into the town. He is married with 4 or 5 children. Source also confirmed that his wife visits WEST BERLIN. Source could give no new information concerning the a/n defector.
3. RA 14479240 Clifford MURPHY, AWOL wef 14 Nov 53.  
Source could give no new information about the a/n defector. She claimed that he wishes to return to the WEST, but is afraid of a heavy sentence if he does so. If he did return his wife would join him. His wife often visits WEST BERLIN (para 3 of Annexure I refers).
4. RA 20116324 Arthur DE ROCHE, AWOL wef 29 Oct 54.  
Source confirmed that the a/n is married and working in KARL-MARK-STADT (formerly CHEMNITZ) and could give no new information concerning this defector.
5. George SMITH.  
Source could give no new information about the a/n.
6. RA 3363089 William D. CLAYTON, AWOL wef 26 Mar 52.  
Source could give no new information about the a/n defector.
7. RA 13479071 James W. PULLEY, AWOL wef 16 Jul 55.  
Source could give no new information about the a/n defector.
8. John SYKES.  
The a/n finished his schooling at the same time as McLANE (15 Nov 57) and is now employed in LEIPZIG as a coal-heaver. He is not politically minded and wishes to return. He is not a heavy drinker and does not go out much with women. No further details.
9. RA 53164551 Willie AVENT, AWOL wef 8 Mar 56.  
Source could give no new information about the a/n defector, but stated that he does wish to return to the WEST, however, he is afraid of punishment in the DDR if he attempts to escape and fails and of punishment by the US military authorities if he succeeds.
10. John DELTON-COEY.  
Source confirmed previous information and could provide nothing new about the a/n.

11. Victor GROSSMAN.

Source could give little information about the a/n, other than he is at present in LEIPZIG and is politically active. No further details.

12. Source could give no information concerning other AMERICAN defectors in the communist bloc. Upon the completion of our interrogation, source was placed at the disposal of the OSI/USAF and CIC/US Army in BERLIN.
