INCLOSURE 3 (DEFENSE AGAINST SOUND EQUIPMENT) to Appendix 2 (UNIT FUNCTIONS) to Annex A (ORGANIZATION AND FUNCTIONS) to 316th INTC Det Tac SOP (U)

1. (U) This inclosure delineates the functions and responsibilities of the Defense Against Sound Equipment (DASE) Section of this unit. The functions listed are stated in general terms. The personnel authorized this section are listed in Appendix 3, this annex.
2. ~~(S)~~ The DASE section has the following functions.
 - a. Be capable of establishing operations within the shortest possible time.
 - b. Be capable of operating over extended periods of time.
 - c. Be located so as to be secure from enemy observation and fire.
 - d. Have necessary technical reference materials available.
 - e. Have available necessary technical equipment to perform assigned missions.
 - f. Have facilities available to enable section to secure classified materials.
 - g. Provide for the rendering of technical advice and assistance to counterintelligence personnel.
 - h. Be familiar with the provisions of AR 380-42.
 - i. Be capable of detecting and removing clandestine surveillance and listening devices from a room, building, or area.
 - j. Be familiar with the techniques involved in the use of countermeasures equipment.
 - k. Be familiar with the theory and operation of countermeasures equipment.
 - l. Maintain equipment as necessary.
 - m. Be capable of installing the following clandestine surveillance and listening devices.
 - (1) Telephone by-pass.
 - (2) Radiation-type transmitter in a vehicle.
 - (3) Clandestine recorder installation in both a fixed location and a vehicle.
 - (4) Telephone line tap, direct and induction.
 - (5) Microphone plants.

- o. Be able to recognize anti-intrusion devices used in securing a building, room, or area.
 - p. Be capable of by-passing various alarm systems.
 - q. Be capable of recognizing anti-intrusion devices used in securing a safe or file cabinet.
 - r. Have available detailed technical inspection checklists. (See Annex G.)
3. (U) The DASE section operates under the direction of the Operations Officer.
