30 (AGENCY) On 18 July 1958, the files of the FBI, New York, New York, were examined regarding SUBJECT'S mother, Ida Kuran Scheer, the following information was revealed:

Ida Kuran of 653 Britton Street, Bronx, New York, was a member of Lodge 500J, International Workers Order as of late 1953. She was born in 1900, held Certificate Number 382712 and joined the International Workers Order in March 1947.
