Dear Ms. Knight,

(U//FOUO) I am writing in accordance with President Joseph R. Biden Jr.'s memorandum of October 22, 2021 on the temporary certification of information within certain FBI records under the President John F. Kennedy Assassination Records Collection Act of 1992, P. L. No. 102-526. As discussed below, I respectfully request continued postponement of highly sensitive information beyond the expiration of the intensive one-year review period which concludes December 15, 2022, propose dates for additional review, and provide an anticipated date of final release, when postponement would no longer be necessary. Attached please find the requested index and transparency plan for each record where the FBI proposes continued postponement of the release of certain information.

(U//FOUO) Consistent with the need to maximize government transparency, the FBI re-examined all relevant material previously withheld to release as much information to the public as possible. As a result, the FBI seeks continued postponement of limited information in only 71 records out of the over 140,000 records within its JFK Act collection. The requested postponements are in three categories: (1) information protected from disclosure by court order; (2) names of living law enforcement and national security confidential sources; and (3) the social security numbers (SSN) of living individuals.

(U//FOUO) The first category of information within the FBI's JFK Act collection concerns information on Dr. Martin Luther King, Jr. (MLK) that is withheld from the public pursuant to court order. This information remains sealed by order of United States District Court for the District of Columbia until and including May 1, 2027. Disclosure on or before this date would violate the court's order; therefore, the FBI proposes release of this information on May 2, 2027.

(U//FOUO) In the second category, the FBI seeks continued postponement of the disclosure of the names of living law enforcement and national security confidential sources. Per the statutory standard for postponement, disclosure would trigger identifiable harm to intelligence operations and law enforcement of such gravity to outweigh the public interest in disclosure. JFK Act, Sect. 5(g)(2)(D)(i-ii). The FBI protected only the names of these sources in the records, not the information they provided. Confidential human sources are integral to the

success of the FBI's intelligence, national security, and law enforcement mission, and the FBI's ability to recruit and retain confidential human sources depends on the source's understanding that his/her identity will remain confidential. Disclosure of these names would be contrary to the FBI's commitment to protect those who have risked their lives and reputations for the United States, and would undermine the FBI's ability to recruit sources in the future. As such, the significant harm of disclosure to intelligence, national security, and law enforcement operations outweighs the public interest in disclosure of these names. Moreover, disclosing the names alone would not significantly advance public understanding of the events surrounding the assassination.

(U//FOUO) Since harm in the second category is tied to life status, the FBI reviewed its records and public source information to establish whether the individuals protected within this category are deceased or could be deemed to be deceased under the judicially-recognized "100-year rule," where an individual born more than 100 years ago is presumed dead. Where dates of birth or death were located, the FBI withheld the names of only those individuals whom it could not verify were deceased or would not be over 100 years old. In those instances where date of birth or death could not be located, a contextual review was conducted to determine whether the individual could be presumed dead based on the 100-year rule.

(U//FOUO) After December 15, 2022, the FBI proposes periodic life status reviews of redacted names every two years until all confidential source names are released or until December 16, 2042, whichever occurs first. Accordingly, a review and potential release of additional names would occur on December 16, 2024, and every two years thereafter, and if necessary, a final review and release of remaining names would occur on December 16, 2042, when all such individuals could reasonably be presumed dead.

(U//FOUO) In the third category, the FBI seeks continued postponement of the disclosure of the SSNs assigned to living individuals. The FBI likewise reviewed its records and public source information to assess life status for these individuals and protected the SSNs of those for which it could not locate proof of death or could not presume the individual is deceased under the "100-year rule." Disclosure of SSNs risks identity theft, thereby posing an identifiable law enforcement harm greater than any discernable public interest in disclosure per the statutory standard. Moreover, the release of individual SSNs would not advance public understanding of the events surrounding the assassination. Parallel to the review of confidential source names, the FBI proposes periodic life status reviews every two years until all SSNs are released or until December 16, 2042, whichever occurs first. Accordingly, a review and potential release of additional SSNs would occur on December 16, 2024, and every two years thereafter, and if necessary, a final review and release of remaining SSNs would occur on December 16, 2042, when all such individuals could reasonably be presumed dead.

(U//FOUO) The FBI is committed to robust transparency in the release of information from its files to the public. However, this commitment must be balanced against the need to protect information under court seal, safeguard the names of living law enforcement and national security confidential sources, and prevent the compromise of SSNs assigned to living individuals. In accordance with the requirements of the JFK Act as implemented by your presidential memorandum, the FBI respectfully requests continued postponement of disclosure

of the carefully targeted redacted information described above beyond December 15, 2022, per the proposed periodic review and disclosure dates outlined above.

Transparency Plan for FBI Postponements within the JFK Records Collection

(U//FOUO) Per the President John F. Kennedy Assassination Records Collection Act of 1992 (44 U.S.C. 2107 note) (the “Act”), the FBI seeks continued postponement of limited information in only 71 records out of the over 140,000 records within its JFK Act collection beyond December 15, 2022. The FBI’s transparency plan to release all remaining information to the public comprises three categories: (1) information to be released upon expiration of a court seal; (2) the release of the names of law enforcement and national security confidential sources; and (3) the release of social security numbers (SSN) of individuals. Each category is discussed in detail below.

(U//FOUO) Category of information: Dr. Martin Luther King, Jr. (MLK) information sealed by order of United States District Court for the District of Columbia until and including May 1, 2027. The FBI proposes release of this information on May 2, 2027.

(U//FOUO) Category of information: Names of law enforcement and national security confidential sources. Since postponement in this category is tied to life status, the FBI proposes periodic life status reviews of redacted names every two years until all confidential source names are released, or until December 16, 2042, whichever occurs first. Accordingly, a review and potential release of additional names in this category would occur on December 16, 2024, and every two years thereafter, and if necessary, a final review and release of remaining names would occur on December 16, 2042, when all such individuals could reasonably be presumed deceased under the judicially-recognized “100-year rule,” where an individual born more than 100 years ago is presumed dead.
