1. WISH MAKE INSTRUCTIONS IN REF MORE PRECISE. ALTHOUGH MR. ⁰⁵DECKER HAS SECRET CLEARANCE AS CONSULTANT FOR KUKNOB AND KUJUMP, HE HAS NO CP CLEARANCE AT ALL AND SHOULD BE GIVEN NO OP ASSIGNMENT BY MEXI. IF MEXI NEEDS INFO ON CONF, IT MAY ASK ⁰⁵DECKER THROUGH IDEN BUT SHOULD NOT COMMISSION ⁰⁵DECKER OR IDEN TO GO OUT AND PROCURE SUCH INFO.

2. IDEN IS ACCOMPANYING ⁰⁵DECKER AS CONSULTANT TO ADVISE ⁰⁵DECKER OF TECH ASPECTS OF AERONAUTICS FEDERATION MATTERS. IDEN WILL REMAIN BEHIND THE SCENES. STATION CONTACT AND SUPPORT FOR THEM IS PRIMARILY FOR PURPOSE OF ADVISING IDEN ON SECURITY MATTERS AND PROVIDE COMMO FACILITIES IF NEEDED. SLUG ALL CABLES ²BYFOUR.

3. IN ABOVE ROLE, IDEN IS UNDER CONTROL OF CHIEF OF STATION MEXI, BUT FORESEE LITTLE NEED FOR ANY POSITIVE STATION ACTION IN THIS CASE.
