1. AN OFFICIAL [CHILEAN SERVICE] HAS REQUESTED INFORMATION ON MARCOS DIAZ LANZ, A CUBAN EXILE LIVING IN MIAMI, FLORIDA. DIAZ WROTE A LETTER TO GENERAL AUGUSTO PINOCHET, PRESIDENT OF THE CHILEAN JUNTA, IN GUARDED LANGUAGE REQUESTING DATA ON THE GOVERNMENT OF CHILE WHICH HE COULD USE IN A SERIES OF TALKS BEFORE POWERFUL U.S. BUSINESSMEN. THE LETTER IMPLIES THAT DIAZ IS IMPORTANT BUT PROVIDES NO DATA. GENERAL PINOCHET WOULD LIKE INFORMATION ON DIAZ-Y

2. THE FILES OF THIS AGENCY REFLECT THAT MARCOS DIAZ LANZ, BORN MAY 20, 1928, HAVANCA, CUBA, ALIEN REGISTRATION NUMBER A-11861120, WAS EMPLOYED IN APRIL 1974 AT S.D. BRULL AND ASSOCIATES, 2299 S.W. 27TH AVENUE, MIAMI, FLORIDA. A RECENTLY ACQUIRED SOURCE WHOSE INFORMATION HAS PROVEN ACCURATE<sup>Y</sup> REPORTED, IN NOVEMBER 1964 DIAZ WAS OPERATING AS AN ARMS DEALER UNDER THE ALIAS "PEDRO GARCIA".
