1. AN OFFICIAL [CHILEAN SERVICE] HAS REQUESTED INFORMATION ON MARCOS DIAZ LANZ, A CUBAN EXILE LIVING IN MIAMI, FLORIDA. DIAZ WROTE A LETTER TO GENERAL AUGUSTO PINOCHET, PRESIDENT OF THE CHILEAN JUNTA, IN GUARDED LANGUAGE REQUESTING DATA ON THE GOVERNMENT OF CHILE WHICH HE COULD USE IN A SERIES OF TALKS BEFORE POWERFUL U.S. BUSINESSMEN. THE LETTER IMPLIES THAT DIAZ IS IMPORTANT BUT PROVIDES NO DATA. GENERAL PINOCHET WOULD LIKE INFORMATION ON DIAZ.Y

2. THE FILES OF THIS AGENCY REFLECT THAT MARCOS DIAZ LANZ, BORN MAY 20, 1928, HAVANCA, CUBA, ALIEN REGISTRATION NUMBER A-115611ED, WAS EMPLOYED IN APRIL 1974 AT S.D. BRULL AND ASSOCIATES, 2299 S.W. 27TH AVENUE, MIAMI, FLORIDA. A RECENTLY ACQUIRED SOURCE WHOSE INFORMATION HAS PROVEN ACCURATE, REPORTED IN NOVEMBER 1964 DIAZ WAS OPERATING AS AN ARMS DEALER UNDER THE ALIAS "PEDRO GARCIA" THAT
