1. ALTHO LETTERS FROM ^{DALTON} [REDACTED] SUBSEQUENTLY PUBLISHED IN OTHER LOCAL NEWSPAPERS, PUBLIC REACTION TO DATE HAS BEEN SURPRISINGLY LIGHT.

2. ^{A CUBAN ASSET} [REDACTED] BROUGHT UP THE CASE WITH ^{OUR OFFICER} [REDACTED] AT MEETING ^{DALTON} NOV, BUT APPEARED TO BE UNRUFFLED.
