TO SEND HIS BROTHER TO <sup>USA</sup> ~~PERU~~ ON A SCHOLARSHIP. HE SAID BROTHER, A MEDICAL DOCTOR, IS CURRENTLY IN PERU ON A PERUVIAN SCHOLARSHIP, AFTER HAVING BEEN REFUSED <sup>US</sup> ~~PERU~~ SCHOLARSHIP. (COMMENT: STATION FILES REFLECT THAT <sup>Tinck</sup> ~~PERU~~'S BROTHER, ~~PERU~~ IS A MEDICAL DOCTOR. HOWEVER, WE UNABLE CONFIRM WHETHER HE CURRENTLY IN PERU). <sup>Tinck</sup> ~~PERU~~ SAID HE WOULD ALSO EXPECT A SALARY FROM <sup>US</sup> ~~PERU~~, BUT DID NOT WANT IT DIRECTLY FROM HANDLER DUE FEAR OF BEING PHOTOGRAPHED RECEIVING MONEY FROM AN <sup>US</sup> ~~PERU~~

3. <sup>Current</sup> ~~PERU~~ CLAIMS IDENTITY, <sup>occupation</sup> ~~PERU~~ COMPLETELY TRUSTWORTHY AND IS CURRENTLY BEING USED BY <sup>US</sup> ~~PERU~~ AND ~~PERU~~ FOR DELICATE INVESTIGATIONS. HOWEVER, <sup>Current</sup> ~~PERU~~ ADMITTED THAT IDENTITY WAS SUSPENDED FROM BAR LAST YEAR AFTER ONE OF HIS WITNESSES COMMITTED PERJURY DURING A MURDER TRIAL. ~~PERU~~
