1. AMMUG-1 PLANS RETURN SALV TODAY (28 SEPT).
2. AMMUG-1 TALKED WITH ~~target~~ ON NIGHTS 25 AND 26 SEPT. ALTHOUGH ~~target~~ DENIED KNOWING AMMUG-1, VERY OBVIOUS THAT HE DID IN FACT RECOGNIZE HIM IMMEDIATELY. AMMUG-1 TRIED CONVINCE ~~target~~ OF FIDELITY DENYING HE CUBAN INTEL AGENT, BUT ONLY REACTION WAS BITTER ATTACK AGAINST AMMUG-1 AS "BATISTIANO AND GUSANO SPY", AND ADMISSION THAT ~~target~~ A FANATICAL AND DIE-HARD CASTROITE COMMIE.
