REQUEST BASED ON SECURITY BOTH OP AND STATION.</p> <p>A. WE NOT NOW ABLE JUDGE SIGNIFICANCE OF SUCH POSSIBLY DEROGATORY INFO ON SUBJECTS AS HAVE RECEIVED /AND REPORTED/ FROM AMHIP/2, DELLUNDE, AND LAPOGO.</p> <p>B. THUS LACK BASIS FOR JUDGING ACCURACY AND VALUE A/2 AND DELLUNDE REPORTING ON THIS TOPIC, AS NEED TO DO AS PART OF ASSESSMENT.</p> <p>C. RE LAPOGO, REALIZE HQS NOT ABLE ALWAYS GIVEN PRIOR NOTICE RE TIMING AND PURPOSE SUBJECTS TRAVEL, SINCE PARTLY FOR PERSONAL REASONS, BUT BASIC DATA ON OP WOULD HELP US ESTIMATE SIGNIFICANCE OF SUCH UNANNOUNCED VISITS AS REF B.</p> <p>D.
