1. SABOTAGE PROGRAM AGAINST CUBAN SHIPPING IS OF SUFFICIENTLY HIGH PRIORITY TO REQUIRE UTILIZATION ANY APPROPRIATE ASSET, PARTICULARLY THOSE WHO ARE NOT PLAYING VITAL ROLE IN SOME OTHER KUBARK PROGRAM. ON BASIS OVERALL CUBAN EQUITIES, HQS OF OPINION THAT NO AMLEG AGENT AT PRESENT ON THE ROLES IS EXCLUDED FROM SABOTAGE DUTIES IF HE IS SUITABLE AND WILLING TO ASSIST. REQUEST THAT ADDITIONAL CREWMEN WHO ARE SUITABLE FOR SAB OPS BE RECRUITED. NATURALLY, WE EXPECT EACH BASE OR STATION INVOLVED TO DO EVERYTHING POSSIBLE TO PROTECT AGENTS FROM COMPROMISE.

2. CALVIN D. KIMENT WILL BE ARRIVING (IN HAMB) CIRCA 1 MAY AFTER STOP (IN FRAN) TO BRIEF COS CIRCA 30 APRIL. WILL GIVE ON THE SPOT GUIDANCE ON SABOTAGE INCLUDING DISCUSSIONS OF USE AND STORAGE (OF SABOTAGE HARASSMENT KIT) WHICH WILL BE READY FOR TRANSMITTAL TO FIELD CIRCA 1 MAY. KIMENT WILL ADVISE ETA (FROM HAGU). HE IS KNOWN TO (UPHILL) AS KUBARK SABOTAGE TECHNICIAN.
