1. ACTION REQUIRED: PLS ADVISE BY COB 10 SEPTEMBER WHETHER PARA TWO INDIVIDUALS CAN BE LOCATED.

* 2. THE<JFK ASSASSINATION>RECORDS REVIEW BOARD IS CONSIDERING THE RELEASE OF DOCUMENTS THAT CONTAIN THE TRUE NAMES OF FORMER TOHIGHROAD STAFF EMPLOYEES OR CONTRACT AGENTS WHO WERE IN MEXICO AT THE TIME OF THE<JFK ASSASSINATION,>AND WHOSE LAST KNOWN LOCATION WAS IN MEXICO. HQS MAY WISH TO OBTAIN IMPACT STATEMENTS FROM THOSE INDIVIDUALS IF THEY CAN BE CONTACTED, TO ASSIST IN PROTECTING THEIR IDENTITIES SHOULD THEY SO DESIRE. - D. IDEN D: US CITIZEN, STAFF EMPLOYEE, IN MEXICO AS OF 1970.
- E. IDEN E: US CITIZEN, CONTRACT AGENT, IN MEXICO AS OF 1970.
