 DYOUP ANALYSIS AND WAS, IN EFFECT, BASIS OF OUR BROAD EFFORT
 MOVE ALL INTERNATIONAL AND REGIONAL ASSETS INTO BOLIVIAN SITUATION
 AND INTO IMMEDIATE CONTACT WITH NEW CGB STATION WILL NOTE
 ACTIONS TAKEN IN TRADE SECRETARIAT FIELD ALONG THESE LINES.

2. OUR FITCH TO RINBEING BASED SAME ANALYSIS. HIS RESPONSE
