1. ARISMENDI TRUJILLO MOLINA LEFT GUATEMALA BY AIR ON 7 JUNE 1964 FOR PANAMA CITY, PANAMA, FROM WHERE HE PLANNED TO GO TO JAMAICA AND BOARD A SHIP FOR HAITI. TRUJILLO WAS TRAVELLING WITH A TOURIST CARD IN THE NAME OF JOSE ANTONIO BARRIOS VALDEZ.

2. PEDRO TRUJILLO, NEPHEW OF TRUJILLO, WILL REMAIN IN GUATEMALA UNTIL HE RECEIVES ORDERS FROM TRUJILLO FROM HAITI. PAULINO A. SIERRA MARTINEZ, A CUBAN WHO IS A CLOSE FRIEND OF TRUJILLO, LEFT GUATEMALA AROUND 1 JUNE AND IS POSSIBLY IN JAMAICA OR HAITI AWAITING THE ARRIVAL OF TRUJILLO.

HEADQUARTERS COMMENT: TDCS 3/582,395, DATED 27 MAY 1964, REPORTED 8 JUN 16 1964 PLOTTING FOR A POSSIBLE INVASION OF THE DOMINICAN REPUBLIC FROM HAITI.
