1. Reference is made to the name check request dated 7 September 1960, subject as above, whose name you desired checked against the files of this office. In addition to the information contained in our CSCI-3/758,793 of 20 September 1960, Subject: Soviet Contacts with Americans in Denmark, the files of this office contain the following information concerning the subject of your request.

2. According to a report dated 7 January 1960 from an official Danish source, Rembert Caven ALLEY, born 30 October 1932, in Erie, Pennsylvania, arrived in Denmark on 29 August 1959. Subject, an employee of the Danish engineering firm, "Danish Arctic Contractors", had been assigned to it's Copenhagen office, where he was to be trained to assist with the company's projects for American military organizations in Greenland. Source stated that ALLEY had been seen a number of times in the company of Vladislav M. ABARCHALIN, who has been described in the above mentioned CSCI. Source further stated that there was information which indicated that ALLEY effected the introduction of ABARCHALIN and Marvin KANTOR, who was the subject of separate correspondence between the Federal Bureau of Investigation and this office.
