Memorandum to Mr. Brennan RE: MARIA CELIA GIRONA SANCHEZ ANTONIO DE SOUZA CARVOJAL

The foregoing was furnished to the Liaison Agent on November 29, 1963, by Austin Horn, CIA, who inquired if the Bureau had any objection to CIA initiating an approach of the subjects through the use of Baralt.

OBSERVATIONS:

It is the opinion of the Liaison Agent that CIA does not have a strong foundation for initiating an approach as indicated. The Agency could be on a fishing expedition and we may find it desirable to object to CIA's proposed action in the absence of additional information. We also should bear in mind that the Bureau is free to consider the use of Baralt if we felt this operation should be handled by the Bureau.

ACTION:

The above information is being directed to the attention of the Nationalities Intelligence Section. It is suggested that its reply to CIA be transmitted via Liaison.
