APPR. IT IS PROBABLY TRUE THAT NGO DINH NHU MADE THE STATEMENTS AS QUOTED, AND THAT HE WAS AWARE THAT THEY WOULD REACH AMERICAN OFFICIALS; THE INFORMATION CONTAINED IN THE STATEMENTS, HOWEVER, IS APPRAISED AS POSSIBLY TRUE.

- 1. ON 27 FEBRUARY 1963 NGO DINH NHU SAID THAT HE ANTICIPATED A MAJOR TURNING POINT IN THE WAR IN VIETNAM BY JULY 1963. HE SAID THAT THE VIETNAMESE COMMUNISTS (VC) WOULD MAKE A VIGOROUS EFFORT TO BE SUPERIOR TO THE GOVERNMENT OF VIETNAM (GVN) BY MID-1963, AND THEREFORE COULD BE EXPECTED TO STRIKE IN INCREASINGLY LARGER FORMATIONS. NHU CLAIMED THAT THE GVN HAD TO UNDERTAKE STRONG COUNTERMEASURES TO LESSEN THE IMPACT OF THE VC ACTIONS, AND TO DEFINE MORE CLEARLY THE TREND OF THE WAR IN FAVOR OF THE GVN.
- 2. NHU ALSO COMMENTED THAT THE NUMBER OF AMERICANS, AND THE SCOPE OF AMERICAN ALD, IN SOUTH VIETNAM SHOULD BE REDUCED. NHU STATED THAT THE NUMBER

OF AMERICANS CONSTITUTED A VC PROPAGANDA ADVANTAGE, BUT WAS INSUFFICIENT TO OVERCOME THE DISADVANTAGES AND VULNERABILITIES, AND THAT ALL AMERICANS NOT ABSOLUTELY ESSENTIAL SHOULD BE WITHDRAWN. NHU FURTHER STATED THAT THE GVN SHOULD SEEK MEANS OF REDUCING THE REQUIREMENTS FOR AMERICAN ECONOMIC ASSISTANCE, SINCE SOUTH VIETNAM MUST ACHIEVE AS MUCH SELF-SUFFICIENCY AS POSSIBLE.

- 3. NHU SAID THAT HE HAD NO RESPECT FOR THE CRITICS OF THE REGIME, BOTH IN SOUTH VIETNAM AND ABROAD, WHO, WHILE PRETENDING TO BE INTERESTED IN THE WELFARE OF THE COUNTRY, ACTUALLY ONLY WANTED TO ADVANCE THEIR OWN PERSONAL POWER AND SELF-INTEREST. NHU STATED THAT NEITHER HE, NOR OTHER VIETNAMESE LEADERS, CONSIDERED THE PRESENT ADMINISTRATION, WHICH HE DESCRIBED AS A TEMPORARY PRODUCT OF HISTORICAL NECESSITY, AN IDEAL SITUATION.
