Will interview SAM A. SAIA regarding possible wagering activities at Sam Saia's Two Jays Bar for the purpose of determining whether the Western Union Ticker is used in connection with gambling.

INFORMANTS:

LAWRENCE FRANCIS PARKER, a New Orleans PCI, advised on January 10, 1962 that he personally visited SAIA's Two Jays Bar and observed no evidence of wagering activity at this bar. On January 17, 1962 he also visited this bar and found no evidence of gambling.



Synopsis:

AARON KOHN, Metropolitan Crime Commission, New Orleans, La., was unable to supply additional information indicating gambling activities at SAIA's Two Jays Bar. Lt. JOSEPH MURRAY, NOPD, advised that SAM SAIA and VINCENT DI VINCENTI are suspected of being handbook operators, however there is no evidence that they are operating at Two Jays Bar.

AARON KOHN, Metropolitan Crime Commission, New Orleans, Louisiana, advised that he had no additional information indicating that there is wagering activities occurring at Saia's Two Jays Bar or any information indicating that the Western Union Sports Ticker Service is being utilized for gambling at this operations address. He advised that through sources available to him he believes that VINCENT DI VINCENTI, FRANCIS LORE, JOHN SANTUCCI, PETER JOHN SCAGLIONE and ANTHONY SCIAMBRA, who are possessors of Federal Wagering Tax Stamps are continuing to book race horse bets in New Orleans. He advised that SANTUCCI is a well known walking book in the New Orleans French Quarter and although he has been picked up on numerous occasions by the New Orleans Police Department, he was never apprehended with sufficient evidence to warrant charging him.

Mr. KOHN advised that through sources available to him he is aware that there is a Western Union Sports Ticker in the Two Jay's Bar, but had no information to indicate this sports ticker was being utilized by SAIA for obtaining information for accepting or paying off wagers. KOHN advised that available information to him did indicate that DI VINCENTI, who is a front for SAIA, is utilizing walking vendors to accept wagers from established customers, telephone the bet to a central headquarters and maintain no records on their person which would indicate wagering was being handled. KOHN did not know the location of the central headquarters.

Lieutenant JOSEPH MURRAY, New Orleans Police Vice Detail, advised that he, personally, members of his squad and uniformed officers of the New Orleans Police First District have maintained for a number of months a close check on the Two Jays Bar in an effort to establish that this is a location where wagers are accepted or paid off. He advised that this is a barroom that is frequented by individuals whom he considers to be interested in sporting events but no information has been developed which would indicate that there is any gambling activity taking place in the barroom and there is no indication that the Western Union Sports Ticker is being utilized in connection with the sporting events.
