According to [Bureau source 6] on 8/6/65, the [C] [S] [Guatemalan Embassy in Port-au-Prince] Haiti, advised the [Guatemalan Foreign Ministry] that a Cuban lawyer named Paulino Sierra who resides in Guatemala had asked that he be granted an interview with Duvalier. (S) (T) (A)

It was indicated that Sierra wanted to establish a fishing company in Haiti which would be used as a screen for operations against communists in Cuba. (S) (T) (A)

[C] [S] According to [Bureau source 6] Paulino Sierra had indicated an interest in financing an exile movement against the Cuban Government in 1963. [Bureau Source 6] data must not be included in material prepared for dissemination and is to be used for lead purposes only. (S) (T) (A)

Bureau will furnish your office any additional details which might be learned concerning this matter through [Bureau Source 6]. (S)
