SEBASTIAN JOHN LA ROCCA, AKA, AR. RE PG TELS TO BUREAU AND
CLEVELAND EIGHT ELEVEN INSTANT. ROBERT CARPER, NEGRO, TWENTY-
SIX, FURNISHED INFO IN RETELS. HAS FURNISHED RELIABLE INFO TO
PSP IN RECENT PAST AND WAS RECENTLY OPENED AS PCI PITTSBURGH WITH
THREE CONTACTS TO DATE BY BUREAU AGENT. INFO RE NUMBERS OPERATION
MERCER COUNTY, PA., VERIFIED BY SEVERAL OTHER SOURCES INCLUDING
THOSE IN LAW ENFORCEMENT. HOWEVER INFO RE NUMBERS TARGETS NOT
CORROBORATED TO DATE. CARPER RECENTLY ARRESTED FARRELL, PA.,
PD ON ARMED ROBBERY CHARGE AND PRESENTLY OUT ON BOND. STATES
MURDER RUMOR CAME FROM GENERAL CONVERSATION AMONG RACKETEERS
MERCER CO., AND COULD NOT BE PINPOINTED FURTHER AT TIME OF CONTACT.
PCI STATED HE WILL ASCERTAIN FULL NAME OF THE FARRA TO BE KILLED
AND WILL ATTEMPT TO OBTAIN FURTHER DETAILS. INFO REGARDING
