The enclosed letterhead memorandum is classified "Secret" since the information furnished by CIA was so classified. In the event of downgrading, it should be (u) classified "Confidential" since it reveals investigative interest in a foreign diplomatic official and the information furnished by WF T-1 could tend to identify the informant of continuing value and compromise future effectiveness thereof. It should be further classified "Confidential" since the information furnished by the State Department was so classified.

The evaluation memorandum is classified "Confidential" since it reveals investigative interest in a foreign diplomatic official.
