ReBulet 12/6/62, entitled "Fair Play for Cuba Committee; Registration Act - Cuba," which set forth information regarding subject's plans to visit countries in North Africa.

(S)
[Bureau Source 6] has furnished information indicating that one Loeches in [Rabat, Algeria] was in contact with the [Foreign Ministry of Cuba] on 12/14/62. At that time, Loeches indicated that the subject had requested that his salary be forwarded in the future to the revolutionary newspaper in Algeria in the name of the Directors of that paper. The source explained that the newspaper involved was probably "El Mudjaevide," which is an Algerian weekly newspaper. (S) (JFK)

Information [from Bureau Source 6] should not be incorporated in any correspondence for dissemination outside the Bureau. It should be used for lead purposes only and must not be disseminated. (S) (JFK)

The above is for your information in continuing investigation of subject and may be an indication of his status as an agent for the Cuban Government necessitating registration. (S) (JFK)
