TESTIMONY OF ROBERT T. SHAW

Mr. Goldsmith. Would you state your name and address for the record?

Mr. Shaw. Robert T. Shaw, 3715 Acosta Road, Fairfax, Virginia, 22031.

Mr. Goldsmith. What is your present occupation, Mr. Shaw?

Mr. Shaw. I am undercover with the Department of State, but my actual occupation is Inspector, Office of the Inspector General, Central Intelligence Agency.

Mr. Goldsmith. Mr. Shaw, I handed you earlier a copy of a letter from the Acting Director of the Central Intelligence, Mr. Carlucci, to the Chairman of this Committee. It corresponds to JFK Exhibit No. 94 in the Committee's hearing record.

Have you had a chance to read that letter?

Mr. Shaw. I read it just now.

Mr. Goldsmith. Do you understand it?

Mr. Shaw. I understand it.

Mr. Goldsmith. I also would like to hand you the Committee's rules and resolutions and ask you at this time to read Rule No. 4 to yourself.

(Pause)

Mr. Shaw. I read it over.

Mr. Goldsmith. Do you understand that?

1 Mr. Shaw. I understand it.

2 Mr. Goldsmith. Do you understand that you have a right
3 to counsel?

4 Mr. Shaw. Yes.

5 Mr. Goldsmith. Do you waive that right to counsel?

6 Mr. Shaw. I do not need counsel.

7 Mr. Goldsmith. Do you understand that, under the
8 Committee rules, that you have a right to receive a copy of
9 the statement you are going to give us at this deposition?

10 Mr. Shaw. I should hope so, to check it for accuracy.

11 Mr. Goldsmith. However, by virtue of the arrangement
12 that the Committee has worked out with the Central Intelligence
13 Agency, we have been asked to request of Agency employees that
14 they waive their right to receive a copy of the deposition
15 for their own retention. By that, I mean we would certainly
16 be willing to grant you access to the deposition, to correct
17 it in any way necessary, but the Agency has requested that
18 we ask you to waive your right to receive an actual copy of
19 the deposition.

20 Mr. Shaw. I have no problem with that.

21 Mr. Goldsmith. Thank you.

22 For the record, I would like to say that the Committee's
23 mandate is to investigate the assassination of the President.

24 The scope of the mandate includes who killed the President,
25 was there a conspiracy? We are also required to evaluate

1 the performance of the investigative agencies, specifically
2 the FBI and the CIA and to evaluate the work of the Warren
3 Commission.

4 Do you understand that as well?

5 Mr. Shaw. Yes.

6 Mr. Goldsmith. Prior to coming here today, have you
7 discussed what your testimony is going to be with any CIA
8 employee?

9 Mr. Shaw. I have not, except to tell them that I was
10 going to tell the truth when I got over here.

11 Mr. Goldsmith. In terms of discussing the substance of
12 your testimony?

13 Mr. Shaw. None whatever.

14 Mr. Goldsmith. Have you discussed with any CIA employee,
15 past or present, who either has been interviewed by the
16 Committee or has given a statement under oath to the Committee,
17 what questions were asked of him or her?

18 Mr. Shaw. I have not.

19 Mr. Goldsmith. Are you here today voluntarily and
20 without subpoena?

21 Mr. Shaw. Yes.

22 Mr. Goldsmith. Mr. Shaw, how long have you been working
23 under State Department cover?

24 Mr. Shaw. Since approximately the date I came aboard,
25 because I was promptly sent to the Department of State for

1 training. That would be March, 1948.

2 Mr. Goldsmith. Would your State Department file, if
3 reviewed by a member of this Committee, indicate that you were
4 actually a CIA employee?

5 Mr. Shaw. I have no idea.

6 Mr. Goldsmith. You do not understand how the cover
7 arrangement would work between the Agency and the Department
8 of State?

9 Mr. Shaw. I have never had anything to do with the
10 setting up of such cover. It would well be that there might
11 be some sort of an indicator or flag, or something in that
12 file that would indicate to a person who knew the ropes that
13 I was not bona fide.

14 Mr. Goldsmith. Would there be a personnel file on you
15 at the Central Intelligence Agency?

16 Mr. Shaw. Yes.

17 Mr. Goldsmith. As a matter of procedure, in terms of
18 how you get paid, do you get paid by the Department of State?

19 Mr. Shaw. No. I am under, at the present time, nominal
20 state cover. I actually, as far as the Department of State
21 is concerned, resigned over there in 1973, I believe. At
22 the present time, I am paid by the Agency.

23 Mr. Goldsmith. When you were working under cover, were
24 you being paid by State at that time?

25 Mr. Shaw. Yes, I was.

1 Mr. Goldsmith. Are you familiar at all with the
2 literature that has been generated by the assassination of
3 the President and the work done by the Warren Commission?

4 Mr. Shaw. Very little. I just noticed that green book
5 there a minute ago. I have never read that thing.

6 Mr. Goldsmith. Book 5, for the record, of the Senate
7 Committee Report.

8 Mr. Shaw. I have seen copies of the Warren Commission
9 Report in various places around the government, but I never
10 read it.

11 Mr. Goldsmith. When you were working with the State
12 Department in other than a nominal capacity, what was your
13 title?

14 Mr. Shaw. My last title was Special Assistant to the
15 Ambassador and First Secretary of Embassy, Honduras.

16 Mr. Goldsmith. Did you ever work as a consular officer?

17 Mr. Shaw. Yes, I did.

18 Mr. Goldsmith. When you worked as a consular officer,
19 were you required to fulfill both responsibilities as a con-
20 sular officer and as a CIA employee?

21 Mr. Shaw. To a certain extent.

22 For example, I have never issued a visa. I have issued
23 a passport for another consular officer who accepted the
24 application and I would be on the road in northwestern Mexico
25 and issued the passport to the American citizen concerned.

1 I have done a modicum of what we call protection and
2 welfare work. This would usually involve being again on the
3 road, stopping in, for example, in a prison to see if there
4 was an American citizen there, to find out what the story
5 was, why he was there, how he was being treated and that sort
6 of thing, and relay that information to the consular when I
7 got back.

8 Actually, I have not done much consular work. I used
9 the cover on several occasions, but was never emersed into
10 the role to the point where it interfered with my Agency
11 activity.

12 Mr. Goldsmith. Normally when somebody is acting under
13 State Department cover, is the person required to hold down
14 two jobs at the same time?

15 Mr. Shaw. It depends on the location of the person.
16 As I understand it, people we have, for example, in the Iron
17 Curtain countries, or the countries of Eastern Europe, do
18 hold down virtually 100 percent full-time State Department,
19 Foreign Service jobs. Some of the people that I have run into
20 in my work as an Inspector for the Office of the Inspector
21 General, notably in the Mid-Eastern countries, have spent much
22 more time on their cover work than I did.

23 I think that it has to do basically with the permissive-
24 ness, or lack thereof, of the operational environment that
25 you are in. In Mexico, it was not necessary to spend much

1 time, at least not for me, on cover duties.

2 Mr. Goldsmith. How long have you been working for the
3 Office of the Inspector General?

4 Mr. Shaw. Since August of 1976.

5 Mr. Goldsmith. Did you have any responsibility in the
6 writing of the 1977 Inspector General Report pertaining to
7 the CIA's handling of the investigation of the Kennedy
8 assassination?

9 Mr. Shaw. None whatever.

10 Mr. Goldsmith. Has anyone ever interviewed you before
11 pertaining to the Mexico City situation as far as it pertained
12 to Oswald?

13 Mr. Shaw. Yes. It was about that time of '76, some-
14 body interviewed me in the CIA Headquarters building, and I
15 think it was a Senate Committee, but I am not sure. They had
16 some files.

17 Mr. Goldsmith. Did you give your testimony under oath
18 at that time?

19 Mr. Shaw. No, not that I remember.

20 Mr. Goldsmith. Did any CIA person ever interview you
21 concerning Lee Harvey Oswald's activities in Mexico City and
22 the operations of the Mexico City station?

23 Mr. Shaw. I would have to qualify that. We discussed
24 the subject, of course, in Mexico City at the time of the
25 assassination, or immediately after the assassination.

1 But I cannot recall that I was ever called in anywhere
2 and asked for my account of what transpired after the assassina-
3 tion.

4 Mr. Goldsmith. Headquarters never asked you to come in
5 and give a description, for example, of Oswald's activities,
6 to your knowledge, in Mexico City in 1963?

7 Mr. Shaw. No. I would not have known anything about
8 Oswald's activities anyway.

9 Mr. Goldsmith. Are you familiar with the photograph
10 that was taken in 1963 that was reportedly linked to Oswald
11 and which subsequently turned out not to be a picture of
12 Oswald?

13 Mr. Shaw. I am familiar with a photograph that was
14 identified by people at the station in Mexico City as possibly
15 being an American-appearing person. I do not know that it
16 was every considered to be Oswald.

17 I think, if I remember correctly, what they were doing --

18 Mr. Goldsmith. We will get into that. My question is,
19 did anybody from Headquarters ever ask you about that parti-
20 cular photograph or the circumstances surrounding it?

21 Mr. Shaw. Negative.

22 Mr. Goldsmith. Did anybody from Headquarters ever ask
23 you to give a statement or report as to the manner in which
24 the surveillance operation in Mexico City were underatken in
25 1963?

1 Mr. Shaw. No.

2 Mr. Goldsmith. Where were you serving in 1963?

3 Mr. Shaw. From about the middle of April, I was serving
4 in Mexico City in our station.

5 Mr. Goldsmith. How long did you stay in Mexico City?

6 Mr. Shaw. I stayed there until September of 1966.

7 Mr. Goldsmith. Who was the Station Chief in Mexico
8 City?

9 Mr. Shaw. Winston Scott.

10 Mr. Goldsmith. Would you give us your assessment of
11 his competence?

12 Mr. Shaw. Competence. It is difficult, because I was
13 not looking from on high. He was a brilliant man. He was
14 reputed to have a doctorate in mathematics. He had an uncanny
15 ability to remember numbers and he carried in his head the
16 file numbers of what we called P-files in Mexico City. P
17 stood, I think, for personality. A P number usually was four
18 digits or so, maybe five digits.

19 And he carried all these numbers in his head and he could
20 mark something for such and such a file in black ink -- he
21 always wrote in black ink -- putting the number down. He had
22 a very good memory for numbers.

23 Winn and I were friendly. We were not close. We were
24 not on the same level at all.

25 I considered him to be, from my standpoint, a competent,

1 effective, Chief of Station.

2 Mr. Goldsmith. What type of file-keeping system did
3 he have in effect, without asking you to describe it in detail?
4 By that, my question is directed towards his thoroughness and
5 comprehensiveness.

6 Mr. Shaw. I would say that he probably had one of the
7 most -- let me see -- complete file systems in being in the
8 Agency. I think that he, my personal opinion is that he went
9 overboard, and we had so much stuff back in our files, it
10 was hard to believe the amount of paper we had in there.

11 His tendency was not to rely on cross-indexing. If
12 you have a document, this piece of paper means something to
13 you and you want to keep it and it has 15 names on it, he
14 was quite capable of setting up 15 files for the same piece
15 of paper. And we had a tremendous file room.

16 I often wondered if we needed that much paper. It was
17 very thorough. I am not a technician as far as managing
18 files, but I do know that the people who worked in the file
19 room were kept very, very busy.

20 Mr. Goldsmith. Who were Mr. Scott's chief deputies?
21 Let me rephrase the question. Upon which individuals did he
22 tend to rely the most?

23 Mr. Shaw. He had one Deputy who was Allen White. As
24 far as reliance on other people, I would say he relied very
25 heavily on Annie Goodpasture -- not in any way in a command

1 function, but as a Girl Friday.

2 He also seemed to think rather highly of a former one-time
3 FBI agent named George Monroe.

4 Mr. Goldsmith. What about David Phillips?

5 Mr. Shaw. Yes. Dave Phillips ran the, what we called the
6 CA side of the shop, covert action, mostly propaganda. I came
7 to Mexico City with the understanding that I was going to head
8 up the Cuban shop. Very soon after I arrived there, Dave
9 Phillips was tapped -- it was while we were still in the old
10 Embassy building.

11 He was tapped and named the new Cuban Office Chief.

12 Mr. Goldsmith. Did that happen in October '63?

13 Mr. Shaw. I don't know. I do not remember. But it was
14 not too long after I was there, and I was asked, I think by
15 Dave; I don't remember -- if I had any objections to continuing
16 to serve in Cuba.

17 I liked Dave, I respected him. I did not feel that I
18 was being hurt, hurt careerwise, to step back and I was very
19 interested in Cuban operations, so I did willingly, let us say,
20 relinquish command, if you want to, of Cuban Ops and I served
21 Dave as one more officer.

22 Later on, after Dave left, a year or two later, I once
23 again took over the Cuban Ops group.

24 Mr. Goldsmith. You were in charge of Cuban Operations at
25 the beginning. Then Phillips took it over at some point and

1 then, after Phillips left, you went back to that position?

2 Mr Shaw. That is right.

3 Mr. Goldsmith. Our review of Agency records indicates
4 that Phillips would have assumed that position on October of
5 '63. Would that be consistent with your recollection?

6 Mr. Shaw. My recollection would have been, had you not
7 told me this based on your review of the files, that it took
8 place earlier than October, but I do not know. I really do not
9 know.

10 Mr. Goldsmith. My questions are going to be confined,
11 unless I indicate to the contrary, to the period up to the
12 end of 1963. So, from the time of your arrival in Mexico City
13 until the end of 1963, prior to the time that Mr. Phillips
14 assumed the position of Cuban operations --

15 Mr. Shaw. Chief.

16 Mr. Goldsmith. Chief would be the word, and you had those
17 responsibilities, what did those responsibilities include?

18 Mr. Shaw. Since it was not ratified to me upon my
19 arrival that I was, indeed, Chief of Cuban Ops, I simply con-
20 sidered myself to be one more case officer working against
21 the Cuban target. Our basic interest was in effecting pene-
22 trations of the Cuban government.

23 What we wanted most of all were effective penetrations
24 of the Cuban Embassy, the Cuban Intelligence Service, and some
25 possible line-in to their communications set-up.

1 Mr. Goldsmith. In 1963, did you manage to place any
2 penetration agents in the Cuban Embassy or consulate?

3 Mr. Shaw. Did I?

4 Mr. Goldsmith. Did the station?

5 Mr. Shaw. There were two. I did not place either one,
6 and I think they both pre-dated 1963.

7 Mr. Goldsmith. Were those two penetration agents within
8 the Cuban consulate or Embassy at the time of the President's
9 assassination?

10 Mr. Shaw. Yes. One was in the consulate -- LITAMIL-7
11 was the cryptonym. L-I-T-A-M-I-L-7. And the other one was
12 in the Embassy -- L-E-I-T-A-M-I-L-9.

13 Mr. Goldsmith. What information did these people give
14 you after the assassination pertaining to the possible involve-
15 ment of the Cuban government?

16 Mr. Shaw. I did not handle LITAMIL-7, and LITAMIL-9. I
17 did handle,

18 Mr. Goldsmith. Who handled LITAMIL-7?

19 Mr. Shaw. I think that it was Ray Swider, but I am not
20 sure. I did not meet LITAMIL-7 until Ray Swider left the
21 country.

22 Mr. Goldsmith. You nevertheless have had access to the
23 information that this individual gave to Swider?

24 Mr. Shaw. I would normally have seen copies of contact
25 reports which were reports that we wrote -- any of us who were

1 case officers wrote -- after station meetings, and it would
2 have been normal for me, for example, to see any information
3 of consequence that LITAMIL-7 produced, just like it would
4 have been normal for any other case officer in the Cuban sec-
5 tion to see my contact reports on meetings with LITAMIL-9.

6 Mr. Goldsmith. In light of that, do you know what infor-
7 mation LITAMIL-7 gave concerning the Cuban government's reac-
8 tion to the death of the President?

9 Mr. Shaw. I do not recall, and I do not recall the
10 specifics of anything. You may have something in your files
11 with my name on it; I do not know what LITAMIL-9 produced.
12 I do have the recollection of the sense of feeling on the
13 part of those people that there was no exultation or jubila-
14 tion or happiness whatsoever inside the Cuban Embassy at the
15 assassination of President Kennedy.

16 Mr. Goldsmith. Did the penetration agents ever indicate
17 that Oswald had been to the Embassy and had stated that he was
18 going to attempt to kill the President?

19 Mr. Shaw. No, not that I know of.

20 Mr. Goldsmith. Did any of those agents ever indicate that
21 Oswald had had contact with the Agency -- with the Embassy,
22 rather?

23 Mr. Shaw. I would imagine that LITAMIL-7 probably did --
24 I do not recall it. But since she was in the consulate, and
25 --since it was my understanding that Oswald's contact with the

1 consular field rather than with the Embassy field, I should
2 imagine, given the discussions that undoubtedly took place in
3 the Cuban Embassy after this assassination, that she probably
4 spoke about it. I do not know.

5 Mr. Goldsmith. What was the name of LITAMIL-7?

6 Mr. Shaw. I'd rather not give names.

7 (Discussion off the record.)

8 Mr. Goldsmith. Mr. Shaw, in light of your response, I am
9 certainly aware of the sensitivity of this issue and of your
10 concern for sources and methods, and I would also make two
11 points. One is that under the letter, you are free of your
12 secrecy obligation. At the same time, I am not about to rely
13 upon that letter to compel an answer out of you, because you
14 are here voluntarily today to help us. And, as I said, because
15 I understand your concern for a sensitive source in this case,
16 I am not going to ask you to state for the record the name of
17 either one of these individuals.

18 Mr. Shaw. May I say something at this point?

19 Mr. Goldsmith. Yes.

20 Mr. Shaw. It is my understanding that both of these
21 people are, if they are still alive, are living in Mexico and
22 I do not want to be in a position of revealing a name which
23 could harm either of those people. I notice here that it says --

24 Mr. Goldsmith. You are referring now to the letter from
25 Mr. Carlucci?

1 Mr. Shaw. Yes.

2 "To provide the affected person the opportunity to
3 receive guidance from me or my designees on the applicability
4 of this authorization, particularly to questions which are
5 asked."

6 I would like to get Frank Carlucci to tell me that I would
7 reveal two names of agents, if it is necessary -- or you can
8 find out from the file, probably, who they are.

9 Mr. Goldsmith. Mr. Shaw, I understand your position.
10 I want to make sure you understand mine. I am in no way
11 forcing you to reveal a name. Once you had demonstrated a
12 reluctance to, then, as far as I was concerned, then the
13 matter was terminated.

14 Mr. Shaw. No problem?

15 Mr. Goldsmith. I will say that we will pursue this by
16 contacting the appropriate people at the Agency.

17 Mr. Shaw. I think if you requested the Agency for those
18 two names, it would probably produce them. I wouldn't want to
19 be the guy to say it.

20 Mr. Goldsmith. I understand your position perfectly.
21 I hope you understand mine.

22 Mr. Shaw. I do.

23 Mr. Goldsmith. I would not want you to go back to the
24 Agency and say that the staff of this Committee attempted to
25 compel an answer out of you.

1 Mr. Shaw. I will not say any such thing.

2 Mr. Goldsmith. Fine.

3 For the record, would you spell the cryptonyms of these
4 penetration agents?

5 Mr. Shaw. One of them was LITAMIL-7 -- L-I-T-A-M-I-L - 7.
6 The other was LITAMIL-9.

7 Mr. Goldsmith. Are these two agents still active?

8 Mr. Shaw. Neither one is active. I am quite sure that
9 neither one is active.

10 Mr. Goldsmith. For purposes of clarification, LITAMIL-7,
11 was that agent working out of the consulate?

12 Mr. Shaw. That agent was an employee of the consular
13 section of the Cuban Embassy in Mexico City. LITAMIL-9 was an
14 officer of the Embassy.

15 Mr. Goldsmith. Mr. Shaw, on the question of the identity
16 of these two agents, when you go back to the Agency, could you
17 raise this question with the appropriate individual, appropri-
18 ate superior authority, and we will do the same so that some
19 time this week we can get together on that?

20 Mr. Shaw. I do not see any reason for us to get together.
21 You can get it from them, I am sure. It is just that I have
22 a rather strong feeling about protecting anybody who has
23 cooperated with us.

24 It is not that I consider you do not have a right to that
25 information, if you feel that you need it. It is just that I

5 (Pause)

6 I have been informed by my researcher, Dan Hardway, that
7 the Agency is in the process of looking into this issue.

8 Mr. Shaw. Okay.

9 Mr. Goldsmith. At this time, I would like to get into
10 the area of the telephone taps that were in operation in 1963
11 against the Cuban Embassy and consulate. My first question is,
12 what responsibility, if any, did you have with regard to the
13 telephone tap operation?

14 Mr. Shaw. No responsibility. I saw the product,
15 usually.

16 Mr. Goldsmith. Who was the individual who was in charge
17 of that tap?

18 Mr. Shaw. I do not know whose responsibility it was.
19 I rather suspect that it may have been Ann Goodpasture's, but
20 I do not know for sure. I do not remember.

21 There were two telephone operations, two tap operations.
22 One of them was unilateral and one of them was joint with the
23 Mexican government.

24 Mr. Goldsmith. Which one was the unilateral one? By
25 that, I mean which phones were covered by the unilateral one?

1 Mr. Shaw. There was a mix, and I cannot recall which
2 were which. It may well have been that we were tapping some
3 Cuban Embassy phones unilaterally, and some of them were being
4 tapped jointly. I know that there was coverage on the joint tap
5 operation, which I believe was called LIENVOY. I am not sure.

6 Mr. Goldsmith. That is correct.

7 You indicated that you think Ann Goodpasture may have been
8 responsible for the telephone tap operation against the Cuban
9 operation. What basis do you have for that?

10 Mr. Shaw. Responsible in the sense of picking up the take.
11 I am not sure of that, because I know she did some of that kind
12 of work. I am not sure who did it. We used to get copies of
13 the transcripts and I remember -- I am sure I saw some of the
14 Cuban stuff on joint taps. And then, of course, taps that
15 were run by the Mexican government.

16 Mr. Goldsmith. Did you review the transcripts that came
17 in as a matter of regular routine?

18 Mr. Shaw. Yes.

19 Mr. Goldsmith. Did you read all of them?

20 Mr. Shaw. No.

21 Mr. Goldsmith. Which ones would you read?

22 Mr. Shaw. I would have been interested primarily in the
23 Cuban ones, and what they called the resuma -- it was sort of
24 a Spanish word for resume -- the resuma was a distillation,
25 if you will, of the digest of the joint tap that was prepared,

1 I believe, for the Mexican President. You look at the resuma,
2 which may be two pages, and you may have the gist of what might

4 Mr. Goldsmith. Normally, you read transcripts of conver-
5 sations that took place on telephones of the Cuban Embassy,
6 is that correct?

7 Mr. Shaw. Normally, I read some of that stuff. I do not
8 remember whether I saw it all or not, because quite a bit of
9 it was processed by other people. I do not know who they were,
10 people on the outside, I suppose. And I read summaries of
11 what appeared on these things, but I remember also, at times,
12 seeing the verbatim -- Man Outside says so and so; Person
13 Inside, Woman Inside, says such and such.

14 Mr. Goldsmith. Sometimes you would get summary trans-
15 criptions of the summary conversations or English and sometimes
16 you would get verbatim translations, is that correct?

17 Mr. Shaw. Yes. I would see them, I would not get them.
18 They would go past me. I would see them.

19 Mr. Goldsmith. Was it more likely that what you would see
20 in verbatim form, conversations that took place, for example,
21 in Russian and had to be translated before you received them?

22 Mr. Shaw. I certainly would not see any conversations
23 in Russian, because the Cuban Embassy did not have any Russian
24 conversations. I cannot really answer that question. I am
25 not really sure I fully understand it. I do remember seeing

1 a variety of take, what we call take, from the various tap
2 operations. This take sometimes was processed into English.
3 The stuff that appeared in the resuma was in Spanish. Sometimes
4 the conversations were typed out in Spanish and translated into
5 English. I prefer them in Spanish, because I am at home in
6 Spanish.

7 Mr. Goldsmith. How many people reviewed the take from
8 the surveillance operation of the Cuban Embassy and consular
9 telephones?

10 Mr. Shaw. I have no idea. I assume there were quite a
11 few. The stuff was widely passed around.

12 Mr. Goldsmith. As a matter of routine, how many people
13 would review them?

14 Mr. Shaw. I have no idea.

15 Mr. Goldsmith. How many people were in Cuban operations?

16 Mr. Shaw. I would guess five or six.

17 Mr. Goldsmith. Who were they?

18 Mr. Shaw. Dave Phillips.

19 Mr. Goldsmith. We are talking now about the period 1963?

20 Mr. Shaw. That is right. Dave Phillips, myself, Ray
21 Swider. I am trying to think of the girl's name. We had
22 various secretaries in there. I do not know who was the secre-
23 tary in '63. Peggy Magert. I'm not sure she was there at

25 Of course, Allen White would see it. Winn Scott would see

7 Mr. Goldsmith. Are you saying that there was no routine

10 Mr. Shaw. I am saying that, when I got there, the case
11 officers in Cuban Ops saw this stuff that was routed around
12 through the station and that persisted during the time that
13 I was there.

14 Mr. Goldsmith. I am not sure that the answer --

15 Mr. Shaw. How that was routed, I am not sure.

16 Mr. Goldsmith. Did you customarily see every conversa-
17 tion that came in?

2 picked up the tapes -- don't consider this gospel, but this

5 listening post; some of which had not. But they, in turn,
6 either processed those tapes or took them to people to continue
7 the processing in case they had a foreign language in them, or
8 something, and then turn them over to the station.

9 Somebody went out from the station, probably with a little
10 attache case or something, and picked up tapes again. It is
11 my understanding that the person primarily involved in that
12 was Ann Goodpasture, but I do not know for sure.

13 Mr. Goldsmith. Who was the first person that the trans-
14 cripts would go to upon their arrival at the Embassy?

15 Mr. Shaw. I rather suspect Winn Scott, because I remember
16 great numbers of those white pages that came across our desk.
17 had P numbers written on them in black ink by Winn Scott.

18 Mr. Goldsmith. Do you know how many lines were being
19 tapped at the Cuban consulate and Embassy?

20 Mr. Shaw. I do not know.

21 Mr. Goldsmith. You reviewed the transcripts and summaries
22 of these conversations for two years and you have no idea how
23 many lines were tapped?

24 Mr. Shaw. No. This was fifteen years ago. I can give
25 you a guess.

3 interest was in the Soviets. You had far more converage.

6 Mr. Shaw. I would guess, off-hand, two lines in the
7 Embassy, one line in the consulate.

8 Mr. Goldsmith. Do you know if the Cuban consul's telephone
9 was tapped?

10 Mr. Shaw. If the consulate line was tapped --

11 Mr. Goldsmith. It would have been his?

12 Mr. Shaw. Probably it would have been his, but they may
13 have had a direct line in there. I do not know.

14 Mr. Goldsmith. How would a telephone tap actually work?
15 I am talking now about the actual mechanics of the tap.

16 Mr. Shaw. I do not know. I never had anything do do
17 with them. I know they used to take some of their taps at
18 what they call the junction boxes. These would be the boxes
19 out in the street where lines came in to be fed into this
20 central -- I would rather suspect that the joint operations
21 were mostly done at the central, since the Mexican government
22 simply could have issued orders, you will tap such and such a
23 phone.

24 Mr. Goldsmith. My question is oriented towards the
25 following. Once a tap has been placed on a line, would that

1 mean that all calls, ingoing or outgoing, on that phone would
2 be picked up, so long as the tap is in effect?

3 Mr. Shaw. So long as it is in effect, yes. Whether those
4 would appear in the transcripts is another matter. If it
5 was like a wrong number, or somebody saying pick up three rolls
6 and bring them home for lunch, probably it would not appear on
7 the transcript.

8 Mr. Goldsmith. Who would make that decision?

9 Mr. Shaw. Whoever transcribed the tapes.

10 Mr. Goldsmith. How much time would pass from the moment
11 that a call came in until the transcription passed across your
12 desk?

13 Mr. Shaw. I cannot answer your question with any preci-
14 sion. There was a system in the Embassy whereby if you had
15 a fast-breaking situation, or something like that, you could --
16 I sure would like to get the transcripts of such and such a
17 line fast, and that information would be processed and funneled
18 back in to the Embassy or into the station on a priority
19 basis.

20 I would guess, offhand, that it ran -- again, this is a
21 guess -- five, six, seven days.

22 Mr. Goldsmith. What about the high priority cases?

23 Mr. Shaw. Sometimes you can get that pretty fast.

24 Mr. Goldsmith. Within a day?

25 Mr. Shaw. Yes. We could have somebody looking for a

1 certain call, and I do not recall ever doing that. But it
2 was my understanding that if you expected some situation, that
3 you could levy a requirement -- for example, let me give you
4 a for instance here.

5 Let us suppose that we, the station, someone in the sta-
6 tion was going to make a recruitment pitch to a Soviet officer.
7 It would have been possible for the station to have organized
8 things so that there was a live body and not just a machine
9 hanging over phone calls coming in to the Soviet Embassy in
10 case the guy called up and said, let me tell you the discus-
11 sion I just had, or something like that.

12 This would be a little far-fetched, because a Soviet
13 would not be likely to handle it by phone. But in a case
14 where you are looking for something fast-breaking to protect
15 yourself, being on top of the situation -- it would not apply
16 much to Mexico, but if you had a revolutionary situation
17 breaking out someplace, surely there is a possibility of
18 getting information very quickly off any given line.

19 Mr. Goldsmith. Would the transcripts be reviewed by
20 you in chronological order?

21 Mr. Shaw. I got them in batches and I would review them
22 just in the order in which they came. I might have shuffled
23 them in chronological order, yes. Quite often they came in
24 four or five or six pages stapled together.

25 Mr. Goldsmith. Would they tend to come in chrolological

1 order so you read a transcript from the 15th before the 16th?

2 Mr. Shaw. Generally yes, right.

6 sheet on it, and they would go on to somewhere else. Where
7 they went, I do not know. Sometimes we would mark them for
8 files. Of course, if there were a transcript in there that
9 had specific information on somebody that we were interested
10 in, we would mark a copy for the files and it would go into
11 that person's -- either their P-file, which was their personnel
12 file, or into any operational self-file that would we make,
13 building up background information on a person, the little
14 things like whether an officer's wife was unhappy with the maid
15 or with living conditions or the cost or what have you of the
16 drugstore. These little bits and pieces were built up and
17 those came from transcripts.

18 Mr. Goldsmith. Would these transcripts eventually get
19 sent to headquarters?

20 Mr. Shaw. I do not know. I will say that it was unlikely
21 that Winn Scott ever threw anything away. It was somewhere,
22 probably, in the file room.

23 Mr. Goldsmith. What about the tapes? What would happen
24 with the tapes after a conversation had been transcribed?

25 Mr. Shaw. Again, you are getting into an area where I

1 never had any personal experience. It is my understanding
2 that tapes were erased and reused, and they were used over
3 and over again. Otherwise, we would have ended up with a room
4 full of tapes and there really was no reason to keep them.

5 Now, I would also assume that if there was something
6 important on a tape that they might have held it. I do not
7 know. I do not recall ever saying, hold that tape for me.
8 The transcript usually sufficed as the record.

9 Mr. Goldsmith. Do you know if, at the time of the assassina-
10 tion, that the station had a tape recording of Lee Harvey
11 Oswald's voice?

12 Mr. Shaw. No, I do not know if they did. I think they
13 did not. It was my understanding that what they had was a
14 transcript of some guy calling, again, it is my understanding.
15 I believe he called the Soviet Embassy from the Cuban Embassy,
16 or the Cubans called the Soviet Embassy, I am not sure. But
17 as far as having the tape with Oswald's voice on it, I seriously
18 doubt it.

19 (Discussion off the record.)

20 Mr. Goldsmith. I would like to show you now what was
21 marked here as CIA No. 197 and, for purposes of the record
22 and for your information, the Agency has provided us with its
23 documents. Each page has been assigned a number. The reason
24 it has been assigned a number is so that the Agency can make
25 sure that everything given to the Committee is returned. For

1 reference purposes, we simply use those numbers for a witness
2 when we are going through this pile of materials.

3 Now I would like you to take a look at CIA No. 197, the
4 second paragraph.

5 (Pause)

6 Mr. Shaw. Okay.

7 Mr. Goldsmith. The second paragraph indicates that the
8 station is unable to compare the voices, as the first tape was
9 erased prior to the receipt of the second call.

10 Mr. Shaw. Yes.

11 Mr. Goldsmith. Does that suggest to you that at least
12 one tape was still in existence on November 23rd, the date
13 that this cable was sent? Otherwise, the second paragraph would
14 have said the tapes had been erased, routinely, whatever.

15 Mr. Shaw. It could indicate that. It does not definitely
16 state that. That is an interpretation, certainly.

17 Mr. Goldsmith. Does that refresh your memory as to whether
18 or not there was a taping system?

19 Mr. Shaw. I do not have anything in writing. This did
20 not refresh my memory at all. This probably would have been
21 considered. Was this after the assassination?

22 Mr. Goldsmith. Yes.

23 Mr. Shaw. No, I do not think it necessarily indicates,
24 but I am surprised that it does not say that they were both
25 destroyed, or both erased.

8 indicates that it seems a voice comparison of some kind was
9 made.

10 Mr. Shaw. Yes, or it could well be that this guy, Fine-

1 normal time lag would be two weeks. In other words, the tapes
2 would normally be retained for a two-week period.

3 Mr. Shaw. That is what it seems to say, yes.

4 Mr. Goldsmith. Is that consistent with your memory now,
5 at the time?

6 Mr. Shaw. No, I do not have any idea. I was not involved
7 in tape pick-ups or tape erasures.

8 Mr. Goldsmith. The Oswald telephone calls, as we will see
9 later on, came in within approximately four days of each other,
10 if, as CIA 239 indicates, the tapes were normally retained for
11 two weeks prior to being routinely erased. Does that suggest
12 to you that the Oswald tape was, for some reason, treated in
13 an unusual manner, because either the first call came in, let's
14 say September 27th. By the time the second call came in, the
15 first tape had already been erased.

16 Mr. Shaw. No, it does not suggest that to me. -- what is this m
17 ber here -- because this message came out 9 December 63. What it
18 suggests to me is that, subsequent to the assassination, is
19 that the station was to hold tapes for a minimum of two weeks.

20 Mr. Goldsmith. Please read into the record what 239 says.

21 Mr. Shaw. CS comment: station to erase routine tapes,
22 Soviet Embassy, keeping normal two week lag.

23 Mr. Goldsmith. Does that suggest to you that the normal
24 lag would not be two weeks?

25 Mr. Shaw. This was not addressed to me.

2 Mr. Shaw. There is no reason for me to read this anymore
3 than there is reason for you to read that. The words stand
4 by themselves.

7 ing is prospective in intent. In other words, after December
8 9, 1963, the timelag for retention of tapes prior to erasure
9 would be two weeks.

10 Mr. Shaw. I think it could read that, yes. I do not know
11 what went on between Winn and the station as far as periods
12 for keeping these, but I think what you are trying to do is lead
13 me into a situation of pointing out that the station was remiss
14 in destroying tapes, and I do not believe that is the case.

15 Mr. Goldsmith. I would like to indicate to you, and also
16 for the record, that what I am trying to do here is go over
17 questions that are raised by the documents and the Committee
18 has no predisposition, one way or the other, to reach any
19 particular conclusions.

20 The truth is that unless these questions are asked of
21 you, both the Agency and the Committee will be criticized by
22 people in the future who review these documents and say, why
23 were not these questions asked of you.

24 Mr. Shaw. I can understand why you are asking the ques-
25 tions. I am simply not in a position to tell you, from memory

1 or anything else what the normal station procedure was regard-
2 ing retention of tapes, although, as I did indicate earlier,
3 that the tapes were routinely erased and used over again. As
4 far as the time lag, you know as much about it, and probably
5 more than I do, by now.

6 Mr. Goldsmith. What responsibility, if any, did you have
7 with regard to the photo-surveillance operation against the
8 Cuban Embassy and consulate?

9 Mr. Shaw. I had no responsibility for that operation
10 until after I reassumed the Cuban Ops section which would have
11 been the day Phillips left for Mexico, probably a year or
12 two down the road. I do know, however, that the operation --
13 there was a Cuban photo, or a photo operation against the
14 Cuban Embassy.

15 I do not remember why, but I think that observation was
16 not active in the period when Oswald was in Mexico. If I
17 remember correctly, the man, to the best of my knowledge who
18 handled that, who was actually the inside case officer, if
19 you will, was the little guy who was snapping the pictures,
20 was a fellow by the name of Robert Zambarnadi, and I believe
21 he is retired and living in Mexico. I do not know.

22 Mr. Goldsmith. Who was the station case officer responsible
23 for running the photo-surveillance operation against the
24 Cubans?

25 Mr. Shaw. As far as I know, it was Robert Zambarnardi,

2 technically qualified man.

3 Mr. Goldsmith. There was no one overseeing him?

4 Mr. Shaw. I do not believe so, but maybe Dave was. I
5 do not know. We used to get batches of pictures. One of the
6 things that I would do with the agent that I mentioned earlier
7 was that I handled was take batches of these pictures to him
8 and sit down with him and say, did you ever see this guy, or
9 who was that? And he'd say, that's a courier, or that's the
10 new officer who just arrived, or I do not know who this guy
11 was, but he came in and talked to so and so, that sort of
12 thing.

13 We used to try to identify people with those pictures.

14 Mr. Goldsmith. How many photo bases were there taking
15 pictures of the Cuban consulate and Embassy?

16 Mr. Shaw. To the best of my knowledge, there was only
17 one photo base. At times, the consulate was not covered and
18 the Embassy was. If I may draw you a picture, this would be
19 the block, the compound block. The Cuban Embassy was the
20 big building up here, and there was a little gatehouse down
21 here. I do not remember whether it was in or out.

22 This was the consulate, on the corner. People who would
23 want to get visas would routinely appear here and they would
24 send them down the street and they would go into the consulate.
25 Sometimes they knew where they were going and they came in here,

1 or they asked a cab, take me to the Cuban consulate, they
2 would probably be delivered here.

3 This is a block, a city block. The house from which the
4 photographs were taken is over here on this corner. The
5 photographs were taken long distance down here and here. This
6 was not always covered. This was considered more important,
7 because it was routine -- either there was a lot of routine
8 visa stuff here.

9 Later on, subsequent -- gosh, it must have been a year
10 later. I do not remember just when -- we developed a system,
11 or somebody up here in the states who developed a system
12 whereby the camera would be triggered automatically. That is
13 movement -- sort of like a photo-electric cell or something --
14 movement up here in the picture that the camera was to cover
15 would cause a series of photos to be taken, maybe four or
16 five, zap, zap, zap, something like that.

17 But I believe that, at the time Oswald was in Mexico City,
18 not only was this down for some reason and not functioning,
19 but I believe, had it been functioning, that it would have
20 been individual picture snapping. I do not think that auto-
21 matic equipment was in Mexico at that time. I could be
22 wrong.

23 Mr. Goldsmith. I am not going to be able to introduce
24 this diagram into the record, so I am just going to describe
25 it as best as I can.

1 You indicated that on one block, one corner of that
2 block was a consulate building for the Cubans. The other side
3 of the block was the Embassy building.

4 Across the street was the photo base.

5 Mr. Shaw. This was all wall. This was a compound.

6 Excuse me, if I may interject. There was another building back
7 here that had a theatre downstairs and had offices upstairs.

8 Mr. Goldsmith. Was that within the compound also?

9 Mr. Shaw. Yes.

10 Mr. Goldsmith. Three buildings within the Cuban compound?

11 Mr. Shaw. Yes.

12 Mr. Goldsmith. The photo base was located across the
13 street. It was closer to the consulate than it was to the
14 entrance of the Embassy?

15 Mr. Shaw. That is correct.

16 Mr. Goldsmith. From the diagram that you drew, it would
17 seem that the location of the camera was closer to the consulate
18 than it was to the Embassy entrance, yet you also indicated
19 that most of the people of interest would have been entering
20 the Embassy, not the consulate?

21 Mr. Shaw. That is correct.

22 Mr. Goldsmith. Was not the placement of that camera in
23 an inappropriate position?

24 Mr. Shaw. I imagine that camera was placed wherever we
25 could get it. Getting real straight across from one of those

embassies was very difficult.

I know, had we had our druthers, we would have placed that camera closer up here and the Soviet Embassy had a similar sort of situation, a camera over here and one down here. I believe the closer the better, yes.

Mr. Goldsmith. How many photo bases were there operating against the Soviet compound, without drawing a diagram?

Mr. Shaw. I do not know, but I think there must have been two or three.

Mr. Goldsmith. Are you sure you were not the case officer overseeing the surveillance operation against the Cubans?

Mr. Shaw. I certainly am.

Mr. Goldsmith. So Mr. Zambernardi was not working under you?

Mr. Shaw. I did not consider him working under me, at that time. Later on, when he was replaced and I am not sure whether Dave Phillips was there or not, I did move into this operation. I am trying to think of the cryptonym for the operation. I cannot recall.

And the chap who then handled it was Zambernardi's replacement, I think his name was Humphrey. That was the surname. Lou Humphrey, I think. I am not sure.

Mr. Goldsmith. What was the purpose of the photo-surveillance operation?

Mr. Shaw. Primarily to identify people in touch with the

foreign embassy.

Mr. Goldsmith. Would everyone's picture be taken?

Mr. Shaw. No, no way.

Mr. Goldsmith. Whose picture would be taken?

Mr. Shaw. For example, that you would normally in an operation like this be limited by time available for the photographer. You would be limited by daylight. You would not photograph a milkman, or a mailman or somebody who would be there repeatedly. You would not photograph a staffer of the Embassy if once you knew who he was, unless he was walking with somebody.

You would not photograph a regular visitor to the Embassy, if you knew who he was.

Mr. Goldsmith. Would you photograph all foreigners?

Mr. Shaw. I do not know. I would have to say the answer is no. I never photographed any of them. Do you mean would all foreigners be photographed? I would say, given the limitations that I have enumerated, namely how long a person can sit there and watch, and they have to take a break now and then, daylight, Sundays they probably did not photograph because there is little activity. I am sure there were considerable down periods in this sort of operation.

No, I would say all foreigners were not photographed.

Ideally, you would like to have a picture of anybody who went in and out of there, surely.

1 Mr. Goldsmith. I understand that.

2 My question is, while surveillance base was in operation,
3 would a primary purpose of it be to take pictures of foreigners?

4 Mr. Shaw. Yes. That would have been a primary
5 purpose. Not necessarily foreigners, but people you do not
6 recognize. Foreigners or Mexicans; Mexicans are foreigners
7 to us, of course.

8 Another thing they did, by the way, was they tried to
9 photograph the license plates of automobiles that came to these
10 embassies.

11 Mr. Goldsmith. During what hours were these photo bases
12 in operation?

13 Mr. Shaw. I do not know. I would say most likely during
14 business hours and proper daylight conditions, when the
15 photographer was available to do the job.

16 Mr. Goldsmith. Would you read back that answer?

17 The Reporter: Question: "During what hours were these
18 photo bases in operation?"

19 Answer: "I do not know. I would say most likely during
20 business hours and proper daylight conditions, when the
21 photographer was available to do the job."

22 Mr. Goldsmith. As a matter of routine, when would
23 photographers have been available to do the job?

24 Mr. Shaw. I do not know. I was not involved in these
25 operations. I used to see quite a bit of coverage.

1 Mr. Goldsmith. What were your primary responsibilities
2 when you were down there? You were not involved in the photo-
3 surveillance operation; you were not involved -- excuse me
4 for interrupting you.

5 Mr. Shaw. Go ahead.

6 Mr. Goldsmith. You were not involved in the photo-
7 surveillance operation and you were not involved in the wire
8 tap operation, so, my question is, what was your primary
9 responsibility?

10 Mr. Shaw. My primary responsibility was to try to
11 effect penetrations of the Cuban government. I spent a good
12 bit of time with Cubans of the non-Castro persuasion, attempt-
13 ing to identify Cubans of the Castro persuasion that we might
14 go after.

15 By "go after," I mean attempt to recruit.

16 I spent a lot of time collecting information from the
17 Cuban asset on the outside to process into the intelligence
18 reports on what was happening in Cuba.

19 We had a system set up in Mexico City under an agent
20 called AMSAIE who was the representative of the exile commun-
21 ity. He would arrange to meet, help, debrief, Cubans who were
22 arriving constantly from Cuba on the way to the United States
23 or to Mexico or to somewhere else in the world, people who
24 were exiting Cuba.

25 Mexico did not break relations with Cuba as did the other

1 countries of the Hemisphere. The OAS recommended that;
2 Mexico did not do it.

3 So, when the refugee flow dried up in Florida, we probably
4 had one of the most productive operations there in Mexico
5 City regarding information on what was going on in Cuba.

6 I spent a lot of time with AMSAIL on that.

7 Mr. Goldsmith. Did you ever try to recruit Eusbio Ascue?

8 Mr. Shaw. His name is Eusbio Ascue.

9 Mr. Goldsmith. Yes.

10 Mr. Shaw. A-s-c-u-e. First name, E-u-s-b-i-o.

11 I did not try to recruit Ascue. That may have been
12 attempted prior to my arrival, in which the man who would know
13 about it, if it had been attempted, would be Mr. Thomas
14 Hazelit.

15 Mr. Goldsmith. What about Teresa Proenza?

16 Mr. Shaw. No, I never made any attempt to recruit
17 Teresa Proenza?

18 Mr. Goldsmith. Do you know if anyone ever did?

19 Mr. Shaw. I know we had an officer in Washington who
20 had formerly served in Mexico City who was very interested
21 in Teresa Proenza. That officer's name was Charles Anders.

22 Mr. Goldsmith. Is he still with the Agency?

23 Mr. Shaw. It is my understanding that he is.

24 Mr. Goldsmith. What about Guillermo Ruiz?

25 Mr. Shaw. That does not even ring a bell. Ruiz is a

1 very common Spanish name. Do you want to tell me who he is
2 or if you have anything on him? Maybe it might ring a bell.

3 Mr. Goldsmith. Apparently, Mr. Ruiz was a Cuban intelli-
4 gence officer at the Embassy, Cuban Embassy.

5 Mr. Shaw. I do not recall him there when I was there.

6 Mr. Goldsmith. What did you say that Mr. Ray Swider's
7 responsibilities were, if you said?

8 Mr. Shaw. I did not say. I used his name -- he was
9 another officer, like I was, in Cuban operations.

10 Mr. Goldsmith. Do you know whether he had anything to
11 do with the photo operation.

12 Mr. Shaw. I do not know. He may have; I do not know.
13 I do not think he did. He may have.

14 Mr. Goldsmith. After your arrival in Mexico City, did
15 anyone attempt to recruit Ascue?

16 Mr. Shaw. As far as I know, there was no attempt made
17 to recruit Ascue after my arrival. My memory could be playing
18 tricks on me. I know I never went after him.

19 (A brief recess was taken.)

20 Mr. Goldsmith. I would like to get into the number of
21 people who were in Cuban Operations in October of '63, September,
22 October of '63. Could you tell me again how many?

23 Mr. Shaw. If you could show me a list of the people at
24 the American Embassy at that time, I think I could pretty well
25 quickly, in the station -- if you have such a list, I probably

3 Mr. Goldsmith. The Agency has not given us that list
4 today to have for this purpose.

8 we have Mr. Phillips, yourself and Mr. Swider.

9 Mr. Shaw. When I arrived there, Tom Hasbrook would have
10 been there. He would have been gone by that time.

11 John Zambèrnardi would have been involved in the technical
12 ops.

13 I am not sure whether Peggy Magret was there or not.

14 Mr. Goldsmith. How many case officers were there in
15 Cuban operations?

16 Mr. Shaw. Probably just three, three or four, I am not
17 sure.

18 Mr. Goldsmith. There were three case officers, probably
19 four?

20 Mr. Shaw. At least three, yes. Dave and Ray and myself.

21 Mr. Goldsmith. Was there a fourth?

22 Mr. Shaw. I do not know. I cannot recall, offhand, who
23 else was there.

24 Wait a minute. Lorna McKay was there, as a researcher --
25 what was it called? Research analyst.

Mr. Goldsmith. I am interested now only in case officers.
I do have a list here, referred to as CIA 169-70, which
has a list of Agency employees. Would you please examine that
list?

(Pause)

Mr. Shaw. Okay.

Perhaps there would have been myself, Ray Swider, Dave
Phillips and Lorna McKay.

Mr. Goldsmith. Was Lorna McKay a case officer?

Mr. Shaw. Lorna McKay was not considered -- yes, I guess
she was a case officer. I do not know what cases she handled.
She did more of what we call INTEL analyst work. She had
officer rank, I believe. I believe she was a GS-9 or -11 or
something. I do not remember.

But Peggy, the girl I mentioned awhile ago, was not there
until 1965. That was about it.

The ranking would have been David Phillips, myself,
Ray Swider, Lorna McKay.

Mr. Goldsmith. How did you divide up your responsibilities?

Mr. Shaw. Let me interject. Jack Stewart was there, but
he was not in Mexico City. He was in Yucatan, in the consulate.

Mr. Goldsmith. Fine.

How did you four divide up your responsibilities?

Mr. Shaw. We were given certain agents to handle and we
handled those agents, and Dave Phillips would decide what

5 might ask any of us to help out, or somebody else might ask
6 us to do something. I went out and helped surveil a meeting
7 one time for one of these guys down here. It had nothing to
8 do with Cuban Ops.

9 Mr. Goldsmith. What procedures did the four of you
10 establish for reviewing photographs?

11 Mr. Shaw. The only procedure that was established was
12 route the photographs and show them to any agent, personnel,
13 who might be in a position to identify the persons in the
14 photographs.

15 Mr. Goldsmith. Did any of you identify all the photographs
16 in the Cuban Operation Branch?

17 Mr. Shaw. I do not know.

18 Mr. Goldsmith. Was there a system to this?

19 Mr. Shaw. If there was, I did not set it up. When I got
20 photographs, I would show them to LITAMIL-9 and have him tell
21 me who they were and I would write a contact report and submit

23 I would assume that Ray Swider probably did the same
24 thing with his agents.

25 Mr. Goldsmith. Mr. Shaw, unless there was a system for

1 reviewing the photographs, you had no way of knowing that
2 all of the photographs were being reviewed by you and other
3 Cuban Operations case officers?

4 Mr. Shaw. I had no way of knowing. I was seeing all the
5 photographs, that is true. I assumed I did.

6 Mr. Goldsmith. You had no way of knowing that?

7 Mr. Shaw. Not unless I would have gone to pick them up
8 from the man who took them and developed them, which I did not
9 do.

10 Mr. Goldsmith. With regard to the transcripts, did you
11 have any procedure for insuring that all of the transcripts
12 were being reviewed?

13 Mr. Shaw. Did I have a procedure? No. The station
14 routed the transcripts to the various officers. Winn Scott
15 quite often routed them. I notice you had a transcript some-
16 where here --

17 Mr. Goldsmith. We will look at the transcripts later on.

18 Mr. Shaw. Winn Scott quite often routed those to a
19 specific officer.

20 Mr. Goldsmith. Were all of the transcripts pertaining to
21 Cuban operations that were sent to the station reviewed by at
22 least one of the Cuban operations case officers?

23 Mr. Shaw. I do not know.

24 Mr. Goldsmith. Was Mr. Scott a very demanding man?

25 Mr. Shaw. What do you mean by "demanding"?

1 Mr. Goldsmith. Did he expect his employees to work hard
2 and to perform thorough, competent work?

3 Mr. Shaw. I assume he did. He never said so in so many
4 words.

5 It was my understanding that until he was remarried he
6 worked long hours in the Embassy, before I got there. Sometimes
7 he had people in there at 9:00 o'clock at night.

8 Mr. Goldsmith. Compared to other station chiefs that
9 you had worked under, was he more demanding or less?

10 Mr. Shaw. I would not say he was any more. He expected
11 work out of his people and got it.

12 Mr. Goldsmith. Is it fair to say that the Mexico City
13 station had one of the biggest telephone surveillance opera-
14 tions in existence?

15 Mr. Shaw. Certainly in Latin America.

16 Mr. Goldsmith. Any CIA station?

17 Mr. Shaw. I don't know about any CIA station. Certainly
18 in Latin America. It ate up a lot of man hours.

19 Mr. Goldsmith. In light of the fact that Mr. Scott
20 apparently was a demanding man and that you had one of the
21 largest surveillance operations in effect in Latin America,
22 your testimony today is that you do not know whether the Cuban
23 operations case officers reviewed all of the transcripts?

24 Mr. Shaw. I do not think that the prefacing was necessary.
25 The latter part of that, in which you asked me if I am aware

1 that all of the transcripts of the Cuban Ops were examined

5 Mr. Goldsmith. We just went off the record for a moment
6 because Mr. Shaw had a question about where his car was parked
7 and whether there would be any problem about that, and I
8 indicated that I did not think there would be a problem.

9 Mr. Shaw, do you recall who delivered the photographs
10 to the station, the tape from the surveillance operation?

11 Mr. Shaw. It was my understanding that the technician
12 picked them up. Bob Zambarnardi would have picked them up
13 from the agent.

14 You are talking of the Cuban Embassy now?

15 Mr. Goldsmith. Yes, and consulate.

16 Mr. Shaw. It is my understanding that he would have
17 picked them up from the agent who took the photographs. The
18 agent who took the photographs developed them, printed them,
19 and turned the prints over to Mr. Zambarnardi. That is the way
20 I think it worked.

21 Mr. Goldsmith. How would you actually get to review the
22 photographs? Who would bring them to you?

23 Mr. Shaw. Usually I do not remember who brought them to
24 me. I have the impression it may have been Lorna McKay, but
25 I could be wrong. Maybe Bob brought them to me. I do not know.

1 But I would get a batch of photographs to go through.

2 Mr. Goldsmith. Who had reporting responsibility for
3 passing along the information that had been obtained from the
4 photographs and the transcripts?

5 Mr. Shaw. There was little reporting that came out of
6 the photographs. Usually, it yielded what we called operational
7 information rather than intelligence information, to enable us
8 to develop a better understanding of who was in the area, of
9 who was in the Cuban Embassy, and what they were up to.

10 As far as reporting intelligence that came from those,
11 it probably was reported by the reports section of the Embassy.
12 Next to Winn Scott's office was the CA Chief's office and,
13 next to that, -- I'm getting in the new embassy now. I don
14 not remember where the report section was in the old embassy.

15 We had reports officers who actually repaired most of the
16 reports from raw reports, if you will, reported by the case
17 officers.

18 Again, I would like to point out that these photographs
19 yielded very little reportable intelligence. It was mostly
20 operational intelligence.

21 Mr. Goldsmith. Understood.

22 Who was George Monroe?

23 Mr. Shaw. George Monroe was a former agent, Special Agent,
24 of the Federal Bureau of Investigation who retired or resigned,
25 I do not know how he left the Bureau, and worked in Mexico

1 City on the outside, as a non-official cover asset for Winn
2 Scott. Ann Goodpasture, I believe, had a lot of contact with
3 George Monroe. I very seldom saw George Monroe. I had nothing
4 to do with him operationally.

5 Mr. Goldsmith. Do you know what his responsibilities
6 were?

7 Mr. Shaw. I believe his responsibilities had to do with
8 dealings with the Mexican government, liaison responsibilities.
9 I think George was used by Winn because George had good contacts
10 in the Ministry of Interior, which would have been sort of the
11 equivalent of the Department of Justice here and out of that
12 Ministry came, for example, the man who became President of
13 Mexico. He was the station asset, contact, not agent.

14 Mr. Goldsmith. You mentioned earlier, Mr. Charles Ander-
15 son, is that correct?

16 Mr. Shaw. Yes.

17 Mr. Goldsmith. Do you know why Mr. Anderson had an inter-
18 est in Eusbio Ascue?

19 Mr. Shaw. No, I do not believe it was. I think it was
20 Teresa Proenza. I do not think he had any interest in Ascue.

21 Mr. Goldsmith. Who was the individual who had the
22 interest in Ascue?

23 Mr. Shaw. I do not know. I said if it had been before
24 my arrival, I would suspect it was Tom Hasley. He was carrying
25 the ball down there and was responsible for that sort of

1 activity. I do not know that he did, but if it happened in,
2 say, late '62 or somewhere in there, it probably would have
3 been Tom who would have done that.

4 Mr. Goldsmith. What was Anderson's position at the
5 Embassy?

6 Mr. Shaw. He was not at the Embassy then. He was at
7 the Embassy back in 1965. I do not know, for a number of years.
8 At that time, Charlie had gone back to Headquarters and he
9 was involved in Cuban operations from Headquarters, the details
10 of which were not made known to me. Whether they were made
11 known to Winn Scott or Dave Phillips or others, I do not know.

12 Mr. Goldsmith. When would he have made an effort, if
13 he did, to recruit Teresa Proenza?

14 Mr. Shaw. I am not sure that he ever tried to recruit.
15 I am merely saying that he had a lot of interest. I do not
16 think anybody ever tried to recruit her. If they did, they
17 were wasting their time.

18 Mr. Goldsmith. Why were they wasting their time?

19 Mr. Shaw. She was a pretty tough nut. I never saw -- if
20 I can remember -- I do not remember any vulnerability of
21 Teresa Proenza.

22 Mr. Goldsmith. What was the nature of Mr. Anderson's
23 interest in her?

24 Mr. Shaw. I do not know. Some Cuban operational interest,
25 maybe trying to get some information from her through a third

1 party. I have no idea.

2 Mr. Goldsmith. When did he spend time in Mexico City that
3 he would have had an opportunity?

4 Mr. Shaw. He visited Mexico City quite often.

5 Mr. Goldsmith. Even though he was not stationed down
6 there, he visited often?

7 Mr. Shaw. That is correct. He made trips in and out of
8 Mexico City.

9 Mr. Goldsmith. Do you know what Teresa Proenza's position
10 was at the Cuban Embassy or Consulate?

11 Mr. Shaw. I think by that time she was out of the Embassy,
12 was she not? I do not remember. She left.

13 Teresa Proenza was a Mexican. She was not a Cuban. And
14 I am under the impression that by the time I got there,
15 Teresa had left the Embassy. I may be wrong. I think that
16 she was involved in cultural activities.

17 Mr. Goldsmith. Do you know whether Mexican intelligence
18 would have had any penetration agents at the Cuban Embassy or
19 consulate?

20 Mr. Shaw. I think they would have tried. I do not know
21 how effective Mexican intelligence was. I did not deal with
22 it.

23 It would be assumed that they made every attempt, the
24 Cubans were gradually removing Mexicans from their employee,
25 from the Cuban Embassy. I think it highly unlikely that the

1 Mexican government, given its position, was the only government
2 in the Western Hemisphere which maintained relations with
3 Cuba, would have been -- it would have been highly unlikely for
4 them to have tried to pitch a Cuban national.

5 On the other hand, I think it would have been likely,
6 and would have been expected of them, to have tried to find
7 out from any Mexican working in the Cuban Embassy what was going
8 on.

9 What this comes down to, of course, is gardeners and
10 secretaries.

11 Mr. Goldsmith. Why do you make that distinction between
12 a Cuban national and a Mexican?

13 Mr. Shaw. I make that distinction because of the flap
14 potential. If the Mexicans had attempted to pitch a Cuban and
15 the Cuban had not accepted that pitch and had reported it
16 to his superiors, the Mexican Foreign Office then would have
17 had a problem with the Cuban Foreign Ministry.

18 Mr. Goldsmith. Of course, the Mexican government was
19 also taking a risk by being involved in the liaison operation
20 or the Agency as well.

21 Mr. Shaw. One could assume that they had measured their
22 risk, yes, certainly. There is an element of risk in every
23 operation. Do not get me wrong. I do not know whether they
24 had anything going or not. I would assume, just based on my
25 experience, that they would not have tried to pitch Cubans,

1 that they would have tried to exert subtle coercion on
2 Mexicans working there to report in the interest of Mexican
3 national security on what is going on in that Embassy.

4 Mr. Goldsmith. Who would have been in a position to know
5 if the Mexican government successfully penetrated the Cuban
6 Embassy or consulate?

7 Mr. Shaw. The President of Mexico would have known.
8 The chief or chiefs of the Mexican service or services.

9 Mr. Goldsmith. Any American?

10 Mr. Shaw. Not that I know of.

11 Mr. Goldsmith. Do you know whether there was any coordina-
12 tion between the telephone tap operations and the photo
13 operations. For example, if a conversation of interest came
14 up on the tap operation, would the people monitoring the call
15 be able to contact through an intermediary the photo bases
16 to warn them or indicate to them that someone is coming of
17 interest?

18 Mr. Shaw. It is my understanding that such a system did
19 not exist, and I do not believe that the guys monitoring the
20 telephone tap intercept bases were made aware of photograph
21 coverage.

22 However, I would assume that a man running a technical
23 operation, if he heard something exciting on the line, as
24 opposed to a tape several days later, would notify his case
25 officer right away and then it might be possible for the case

1 officer, assuming a quick reaction capability, to crank up
2 the people at the photo house to take pictures. This was in
3 the most perfect of all worlds. Usually things did not work
4 that way and you end up out on the street, in the middle of
5 the night two days later, contacting whoever it is taking
6 photographs.

7 Mr. Goldsmith. Do you know whether the Mexico City
8 station ever obtained a photograph of Lee Harvey Oswald?

9 Mr. Shaw. To my understanding, they did not. I never
10 saw anything down there that looked like Lee Harvey Oswald.

11 Mr. Goldsmith. Did you ever hear an allegation that
12 Charlotte Bustos, at CIA Headquarters in Washington, found a
13 photograph of Oswald, or someone she thought to be Oswald,
14 in the Headquarters files shortly after the assassination?

15 Mr. Shaw. No, I have never heard such a story. Knowing
16 Charlotte -- not knowing her well, but having known her over
17 the years, I would assume that had she found such a thing
18 she would have rung a big loud bell and say, hey, look what
19 I found.

20 Mr. Goldsmith. With regard to the photo operation, let
21 us assume for a moment that you come across a picture of
22 interest. Did you have any way of determining on what day and
23 approximately what time the picture would have been taken?

24 Mr. Shaw. Very definitely.

25 Mr. Goldsmith. How would you have done that?

1 Mr. Shaw. The photographs were squared off and were
2 annotated. We knew the day. We knew, usually, morning or
3 afternoon, a.m. or p.m. Sometimes you could judge by the
4 sequence.

5 Furthermore, sometimes the actual time of the person going
6 in and going out was actually annotated, if the person operating
7 was operating manually, he would no doubt, the guy with the
8 red-checkered Hawaiian shirt went in at 10:05. He would note
9 that in a little log.

10 I do not know whether he would note it on the photograph
11 or submit the log with the number keyed to the log in the
12 photograph. Quite often we knew to the minute when a person
13 in a photograph came in or went out or stood in front or walked
14 by.

15 Mr. Goldsmith. I see.

16 So, to your knowledge, there were photo-production logs
17 that could be checked?

18 Mr. Shaw. To my knowledge, such logs did exist, yes.
19 Whether the logs were kept after the information was noted on
20 the photograph, on the back of the photograph or wherever it
21 was noted, I have no idea.

22 The photographs, quite often came in the form of 35 mm.
23 contact strip prints and then blow-ups of a number of those.

24 I recall -- I had not thought about it all these years,
25 but usually you knew when a guy, you certainly knew when he went

3 Mr. Goldsmith. Who would make the notations on the back of
4 the photograph or contact print as to the time?

7 the photographs, printed them and turned them over.

8 Mr. Goldsmith. If he were to put the time on, he would
9 have to go to his log and see what the time was and then make
10 the entry?

1 American going in, and maybe this is the fellow. I do not
2 see from this cable any conclusion that that is Oswald. I
3 rather suspect they never got a picture of Oswald. This is
4 the one that appeared there, that looked like it could be
5 an American. Therefore, an effort was made to help Headquarters
6 by saying a man who looked like he might be an American
7 entered the Soviet Embassy at that time.

8 Mr. Goldsmith. I agree with you, Mr. Shaw. Certainly,
9 the cable does not say that the photograph is a photograph of
10 Oswald. At the same time, though, it gives the information
11 in paragraph 1 on Oswald and the second paragraph makes
12 reference to a photograph taken of someone who appears to be
13 North American.

14 Certainly they would not have sent to Headquarters simply
15 a cable indicating the existence of a photograph, so by putting
16 the photograph in paragraph 2 immediately below the information

6 when he wrote "sic" next to the "Henry" in "Lee Henry Oswald"?

7 Mr. Shaw. I would rather suspect that he wrote this on
8 here subsequent to the assassination when the word came out it was
9 "Harvey Oswald" rather than "Henry Oswald" unless there is
10 something in here that says "Harvey." Is there any?

7 because she was a Mexican national and the Cubans -- she did
8 not have any Cuban diplomatic immunity.

9 I would have thought it would have been a good idea to
10 question here very closely. As to whether I said that she
11 should be arrested or I had anything to do with that, I do
12 not know. I was perfectly capable of making such a suggestion.

13 Mr. Goldsmith. Do you know why Headquarters was upset
14 about that arrest?

15 would indicate to me that if he had been interviewed, he
16 would have been interviewed by the FBI.

17 Mr. Goldsmith. Does not the Agency have a Domestic
18 Contacts Division, or service, which customarily interviews
19 people who have been abroad in Communist countries?

20 Mr. Shaw. The Agency has the Domestic Contacts Division.
21 It used to be called O/O Contacts. I never worked with those
22 people.

23 It is my understanding that what they do is routinely
24 debrief, if the person is willing, businessmen -- in the old
25 days, tourists -- who had visited the Soviet Union, or to

1 debrief a man who might have other involvement in the Soviets
2 would not, I believe, have fallen within the purview of the
3 O/O Contacts Branch.

4 Mr. Goldsmith. Do you have any knowledge of the opera-
5 tional activity of the CI/SIG Branch of the CIA?

6 Mr. Shaw. No. I do not know what SIG means. I have
7 never heard of CI/SIG.

8 CI is Counterintelligence staff. I don't know what SIG
9 is.

10 Mr. Goldsmith. Mr. Shaw, I would like to thank you for
11 your testimony today. I especially would like to thank you
12 for spending all of this time with us. I know that you have
13 been here since approximately 3:00 o'clock or so and it is
14 now about 7:30. You have been very patient.

15 Customarily, whenever a witness testifies before the
16 Committee, the witness is given an opportunity to make a
17 statement for the record. This is not a hearing, but I would
18 like to give you the same opportunity, if you would like to
19 take advantage of it.

20 Mr. Shaw. Well, I might take advantage of it. I had not
21 thought about it until you mentioned it, but harkening back
22 to what I said a little while ago, I do believe that our
23 organization was made up of, like Bill Colby has on the cover
24 of his book over there on the next table, of honorable men,
25 and I do not think that anyone in the organization would have

1 allowed any cover-up or any destruction of evidence which might
2 shed some light on the assassination of President Kennedy.

3 I might add a little vignette. We had what it called a
4 Libra Pecima which is a book that the people signed when
5 they come to a funeral or something. You may have run into
6 something like this in the states, when you go in and sign
7 in at the funeral parlor that you were there or something.
8 You express your regrets -- pecima, in Spanish, means regrets,
9 or sorrow.

10 We had a book down in the lobby of the Embassy building
11 and when I came out one day shortly after the assassination
12 somebody in the crowd yelled Spanish for Bob, and I went over
13 and it was the Governor of the State of Sonora, which is
14 a big state up in northwestern Mexico. I had known him some
15 years earlier. He was the son of the General who was the
16 outstanding military leader of the Mexican Revolution from
17 about 1913 to about 1920.

18 His father had been President of Mexico. His father was
19 assassinated, having been elected to a second term. He was
20 already elected; he had not taken office.

21 I was profoundly touched by the presence of this son of
22 an assassinated President in the lobby of our Embassy to, in
23 turn, express his sorrow to us for the assassination of our
24 President.

25 That does not prove anything one way or another, but it

made a tremendous effect on me.

As I mentioned very early in our session today, I am not aware that there was any exultation, satisfaction, or happiness inside the Cuban Embassy over the assassination of the President. And I think, and my personal belief is, that everything points to Lee Harvey Oswald having done it, and done it alone.

There is nothing I have ever seen or heard which would lead me to accept, for one moment, any complicity on the part of my Agency or any other agency of the United States government.

Mr. Goldsmith. Thank you, Mr. Shaw.

I would like to add that as soon as the transcript of this deposition is available, we will be in touch with you so that you can have an opportunity to review it for accuracy and again, I would like to thank you for your time and help today.

Mr. Shaw. I thank you, gentlemen.

(Thereupon, at 7:30 p.m. the Executive Session recessed.)
