On 1/6/64 MEX-18 and MEX-19 orally advised the writer that during the time ELIZABETH MORA was ill she had declined to discuss the OSWALD case. Informants did not furnish her with any newspaper clippings concerning the OSWALD case, as she had requested, but did call her attention to some newspaper articles, particularly the "Scott Allen" report published in the Mexico City "News," which indicated that OSWALD had reportedly traveled to Mexico in the company of two other individuals. MORA, however, declined to take the lead and to discuss the newspaper reports or anything connected with the OSWALD case. (S)(u)

The informants further advised that during this period of illness, MORA refused to discuss any political matters and her entire attention was absorbed by her illness and her household chores. Her refusal to discuss matters was, therefore, not limited merely to the OSWALD case. (S)(u)

Informants further advised that CHARLES SMALL is still worried, believing that he must have known OSWALD at some time and that OSWALD must have visited SMALL's store while in Mexico. (S)(u)

ALFRED LAWRENCE, who has recently returned on a visit to Mexico, according to the informants, has created even more fright among some of the ACGM associates by taking the position that, of course, the assassination of President KENNEDY was a plot, implying the involvement of the Cubans. (S)(u)
