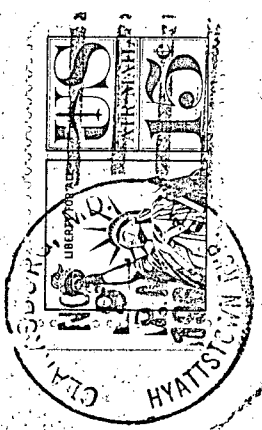

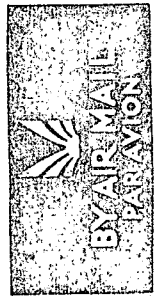

Dear Mr. Collek,

Thank you for your acknowledgement of October 31, which arrived yesterday.

Should you become interested in WHITEWASH: THE REPORT ON THE WARREN REPORT, it will save time for us both if you contact my British agent, Mr. Gordon Harbord, 53 St. Martin's Lane, WC 2, ENGLAND, Phones, Temple Bar 8985/1320. My confidence in and my relationship with Harbord are such that I have empowered him to make any arrangement he wants for my book, without consultation with me. I tell you this because this subject is opening much more rapidly than the press indicates or people generally understand. For example, the recent government actions supposedly making more data available and the return of the pictures and X-rays of the autopsy. These are fraudulent actions intended to and actually accomplishing further suppression. Mr. Harbord now had two additional articles on this subject and I project at least a third as soon as my newest book, WHITEWASH II: WHO DID IT! is published. I anticipate this will be soon.

Proposed book by Harold Weisberg

The sequel does not in any way duplicate WHITEWASH. The two, together, are two parts of my own report on the Warren Report. The second, coming largely from previously suppressed documents that have been kept out of the record and until now unpublished, is in some ways more shocking than the first book. Mr. Harbord has an almost complete copy of this that he can probably show you if you have a representative in England. This book is perhaps the strongest indictment, a self-indictment, of the federal police and intelligence agencies. I have all of the documents and may, eventually, print a supplement of just these documents and pictures, in facsimile. It is an overwhelming thing.
